

The Contract of Insurance

The policy, the application form and/or declaration made by You and The Schedule should be read together and form the contract of insurance between You, The Policyholder and Us Norwich Union

In return for You having paid or agreed to pay the premium for the Period of Insurance, We will indemnify You by payment or, at Our option, by reinstatement or repair, in respect of loss, liability, destruction, damage, accident or injury to the extent of and subject to the terms contained in or endorsed on the policy.

IMPORTANT

This policy is a legal contract. You must tell Us about any facts or changes which affect Your insurance and which have occurred either since the policy started or since the last renewal date.

If You are not sure whether certain facts are relevant please ask Your adviser or local Norwich Union Insurance office. If You do not tell Us about relevant changes, Your policy may not be valid or the policy may not cover You fully.

You should keep a written record (including copies of letters) of any information You give Us or Your insurance adviser when You renew this policy.

Choice of Law

- (1) The law applying in that part of the United Kingdom, Channel Islands or Isle of Man in which You normally live or (if applicable) the first named policyholder normally lives
or
- (2) In the case of a business, the law applying in that part of the United Kingdom, Channel Islands or Isle of Man where You have Your principal place of business
or
- (3) Should neither of the above be applicable, the law of England and Wales.

Our Service to You

Our goal is to give excellent service to all Our customers but We recognise that things do go wrong occasionally. We take all complaints We receive seriously and aim to resolve all Our customers' problems promptly. To ensure that We provide the kind of service You expect We welcome Your feedback. We will record and analyse Your comments to make sure We continually improve the service We offer.

What will happen if You complain?

- We will acknowledge Your complaint within 2 working days of receipt
- We aim to resolve complaints within 5 working days
- Once an assessment and full investigation of Your concern has been made, We will respond with a decision

Most of Our customers' concerns can be resolved quickly but occasionally more detailed enquiries are needed. If this is likely, We will contact You with an update and give You an expected date of response. This will not be beyond 20 working days from when You first made Your complaint.

If You remain unhappy with the decision You receive from the local branch You may write to the Chief Executive. If You are dissatisfied with Our final decision, You can refer the matter to the Financial Ombudsman Service (FOS).

The FOS will only consider Your complaint if You have given Us the opportunity to resolve it and You are a private policyholder, a business with a group annual turnover of less than £1 million, a charity with an annual income of less than £1 million or a trustee of a trust with a net asset value of less than £1 million. Please follow the steps below. If, however, We do not resolve Your complaint within 40 working days, the FOS will accept a direct referral.

Whilst We are bound by the decision of the FOS, You are not. Following the complaint procedure does not affect Your right to take legal action.

What should I do?

The steps You should take if dissatisfied

Step 1 Seek resolution by Your insurance adviser or usual Norwich Union point of contact

If You are disappointed with any aspect

of the handling of Your insurance We would encourage You, in the first instance, to contact the manager concerned. You can write or telephone, whichever suits You, and ask Your contact to review the problem.

Step 2 Refer Your complaint to Our Chief Executive

If You remain unhappy with the decision You receive, please write with full details including policy number and/or claim number, to:

Compensation Scheme

We are covered by the Financial Services Compensation Scheme ("FSCS"). You may be entitled to compensation from the scheme if We cannot meet our obligations. This depends on the type of business and the circumstances of the claim.

For compulsory classes of insurance, insurance advising and arranging is covered for 100% of the claim. For other classes of insurance, advising and arranging is covered for 100% of the first £2,000 of a claim and 90% of the remainder of the claim. There is no upper limit in either case.

Further information about compensation scheme arrangements is available from the FSCS.

Policy Definitions

Each time We use one of the words or phrases listed below, it will have the same meaning wherever it appears in Your policy unless an alternative definition is stated to apply. A defined word or phrase will start with a capital letter each time it appears in the policy.

Each Section of the policy contains definitions. They must be read in conjunction with the following Policy Definitions.

Computer and Electronic Equipment

All computers, computer installations and systems, microchips, integrated circuits, microprocessors, embedded systems, hardware, and any electronic equipment, data processing equipment, information repository, telecommunication equipment, computer controlled or programmed machinery, equipment capable of processing data and/or similar devices, whether physically or remotely connected thereto.

Cyber Vandal

The person or persons, whether identified or not, responsible for, or involved with, creating a Virus or Similar Mechanism or a Denial of Service Attack, unauthorised access to or use of Computer and Electronic Equipment.

Data

All information which is

- (1) electronically stored, or
- (2) electronically represented, or
- (3) contained on any current and back-up disks, tapes or other materials or devices used for the storage of data,

including but not limited to operating systems, records, programs, software or firmware, code or series of instructions.

Data Storage Materials

Any materials or devices used for the storage or representation of Data including but not limited to disks, tapes, CD-ROMs, DVDs, memory sticks, memory cards or other materials or devices which may or may not also constitute Computer and Electronic Equipment.

Denial of Service Attack

Any actions or instructions with the ability to damage, interfere with, or otherwise affect the availability of Computer and Electronic Equipment or Data, including but not limited to the generation of excess traffic into network addresses, the exploitation of system or network weaknesses, and the generation of excess or non genuine traffic within, between or amongst networks.

Employee

Any person who is

- (1) under a contract of service or apprenticeship with You
- (2) borrowed by or hired to You
- (3) a labour master or supplied by a labour master
- (4) employed by labour only sub-contractors
- (5) self employed
- (6) under a work experience or training scheme
- (7) a voluntary helper

while working under Your control in connection with The Business

- (8) an outworker or homeworker when engaged in work on Your behalf.

Failure

Any partial or complete reduction in the

- (1) performance, or
- (2) availability, or
- (3) functionality, or
- (4) the ability to recognise or process any date or time,

of any

- (a) Computer and Electronic Equipment
- (b) electronic means of communication
- (c) web site.

Policy Definitions

Loss of Data

Physical or electronic or other loss or destruction or alteration or loss of use, whether permanent or temporary, of or damage to Data, of whatsoever nature, in whole or in part, including, but not limited to Loss of Data resulting from loss or damage to Computers and Electronic Equipment or Data Storage Materials, including while stored on Data Storage Materials.

Malicious Contingency

- (1) riot, civil commotion, strikers, locked out workers or persons taking part in labour disturbances.
- (2) malicious persons other than thieves and Cyber Vandals.

Money

Current

- (1) coin, bank and currency notes
- (2) postal and money orders, bankers drafts, cheques and giro cheques
- (3) crossed warrants, bills of exchanges and securities for money
- (4) postage, revenue, national insurance and holiday with pay stamps
- (5) national insurance and holiday with pay cards, national savings certificates, war bonds, premium savings bonds and franking machine impressions
- (6) credit company sales vouchers, luncheon vouchers and trading stamps
- (7) VAT invoices.

Period of Insurance

From the effective date until the expiry date (both shown in The Schedule) or any subsequent period for which We accept payment for renewal of this policy.

Program code, programming instruction or any set of instructions with the ability to damage, interfere with, or otherwise adversely affect Computer and Electronic Equipment or Data, whether involving self-replication or not, including, but not limited to trojan horses, worms and logic bombs.

Property Damage - Specified Contingencies Section

Definitions

(Also refer to the Policy Definitions at the front of this policy booklet).

The following definitions apply to this Section and shall keep the same meaning wherever they appear in the Section, unless an alternative definition is stated to apply.

Damage

Loss or destruction of or damage to the Property Insured.

Excess/Excesses

The amount or amounts shown in Your policy or The Schedule which We will deduct from each and every claim at each separate location and will be deducted after the application of Average. See Condition 1.

You will repay any such amount paid by Us.

Property Insured

Property insured as detailed in The Schedule.

Cover

We will indemnify You in respect of Damage occurring during the Period of Insurance at The Premises caused by each of the following Contingencies, if the letter set against it appears on The Schedule.

The Sum Insured under each Item other than Items applying solely to fees, rent, removal of debris, private dwelling houses, churches or buildings in course of erection is separately subject to Average. See Condition 1.

The maximum We will pay under this Section in any one Period of Insurance will not exceed

(1) the Sum Insured on each Item

or

(2) the Total Sum Insured

or

(3) any other maximum amount payable or limit of liability specified in The Schedule.

Contingencies

A (1) Fire.

We will not indemnify You in respect of Damage

(a) caused by explosion resulting from fire

(b) to that portion of any item caused by its' own self ignition, leakage of electricity, short circuiting, or over-running

(c) caused by

(i) its' own spontaneous fermentation or heating

(ii) its' undergoing any process involving the application of heat.

(2) Lightning.

(3) Explosion

(a) of boilers

(b) of gas in a building not being part of any gas works

used for domestic purposes or used for lighting or heating the building.

We will not indemnify You for Damage caused by earthquake or underground fire.

B Explosion.

C Aircraft including

(a) other aerial devices

(b) articles dropped from them.

D Riot, civil commotion, strikers, locked out workers, persons taking part in labour disturbances or malicious persons acting on behalf of or in connection with any political organisation.

We will not indemnify You in respect of Damage caused by or happening through work stoppages.

Asset Protection Property Damage - Specified Contingencies

E Riot, civil commotion, strikers, locked out workers, persons taking part in labour disturbances or malicious persons.

We will not indemnify You in respect of

- (a) Damage caused by or happening through
 - (i) work stoppages
 - (ii) theft or attempted theft caused by malicious persons not acting on behalf of or in connection with any political organisation
- (b) the Excess stated in The Schedule.

F Riot or civil commotion, but limited to Damage by Fire only.

We will not indemnify You in respect of Damage caused by or happening through work stoppages.

G Earthquake.

H Earthquake (but limited to Damage caused by Fire only).

J Earthquake (but not Damage caused by Fire).

K Underground Fire.

L Fire caused by the Property Insureds' own spontaneous combustion.

M Storm.

We will not indemnify You in respect of

- (a) Damage due only to change in the water table level
- (b) Damage caused by
 - (i) escape of water from any water course, lake, reservoir, canal or dam
 - (ii) inundation from the sea
 - (iii) frost
 - (iv) subsidence, ground heave or landslip
- (c) Damage to fences, gates and moveable property in the open
- (d) the Excess stated in The Schedule.

N Storm, Flood and Falling Trees.

We will not indemnify You in respect of

- (a) Damage due only to change in the water table level
- (b) Damage caused by
 - (i) frost
 - (ii) subsidence, ground heave or landslip
 - (iii) escape of water from any tank, apparatus or pipe
 - (iv) felling, lopping or pruning of trees
- (c) Damage to fences, gates and moveable property in the open
- (d) the Excess stated in The Schedule.

P Escape of water from any tank, apparatus or pipe or escape of fuel from any fixed oil heating installation.

We will not indemnify You in respect of

- (a) Damage by water discharged or leaking from an automatic sprinkler installation
- (b) the Excess stated in The Schedule.

Q Impact by any vehicle or animal or by goods falling therefrom.

We will not indemnify You

- (a) if the vehicle or animal is owned by or under the control of
 - (i) You
 - (ii) any member of Your family
 - (iii) any of Your Employees
- (b) in respect of Damage to goods being carried.

R Impact by any vehicle or animal or by goods falling therefrom.

We will not indemnify You

- (a) in respect of the Excess stated in The Schedule if the vehicle or animal is owned by or under the control of
 - (i) You
 - (ii) any member of Your family
 - (iii) any of Your Employees

Asset Protection Property Damage - Specified Contingencies

(b) in respect of Damage to goods being carried.

S Water accidentally discharged or leaking from any automatic sprinkler installation in The Premises.

We will not indemnify You in respect of Damage caused by

- (a) freezing whilst The Premises owned or occupied by You are unoccupied or disused
- (b) explosion, earthquake, subterranean fire or heat caused by fire.

Subject to the following special conditions:

If in relation to any claim for Damage by Contingency S You have failed to fulfil any of the following Conditions, You will lose Your right to indemnity or payment for that claim.

- (1) You must take all reasonable steps to prevent frost and other damage to the automatic sprinkler installation(s) and, so far as Your responsibility extends, to maintain the installation(s) including the automatic external alarm signal in an efficient condition.

In the event of any discharge or leakage from such installation(s), You must do and permit to be done all things practicable, whether by removal or otherwise, to save and protect the Property Insured.
- (2) When any changes, repairs or alterations to the automatic sprinkler installation(s) are proposed You must advise Us and obtain Our agreement to such changes, repairs or alterations.
- (3) We must have access to The Premises at all reasonable times for the purposes of inspection and We will notify You of any defects in the construction or condition of the automatic sprinkler installation(s) requiring alteration or repairs. We may also suspend the insurance provided by this Contingency until such alterations or repairs be carried out or approved by Us.
- (4) This Contingency does not cover Damage to the automatic sprinkler installation(s) other than that caused by water accidentally discharged or leaking from the installation(s).

T Theft or attempted theft

We will not indemnify You in respect of Damage

- (a) caused by or consisting of acts of fraud or dishonesty.
- (b) as a result of
 - (i) disappearance
 - (ii) unexplained or inventory shortage
 - (iii) misfiling, misplacing of information or clerical error.
- (c) the Excess stated in The Schedule.

Exceptions

The following exceptions apply to this Section.

(Also refer to the Policy Exceptions at the back of this policy booklet).

We will not indemnify You in respect of

(1) (a) any consequential loss or damage

However, We will indemnify You in respect of rent when this cover is specified in The Schedule and the Damage is not otherwise excluded.

- (b) Damage more specifically insured by You or on Your behalf
- (c) (i) Damage insured by any marine policy
- (ii) Damage which would be insured under any marine policy if this policy did not exist.

However, We will indemnify You in respect of Damage not otherwise excluded for any sum beyond the amount which would have been payable under the marine policy had this insurance not existed

(d) Damage caused by pollution or contamination.

However, We will indemnify You in respect of Damage, not otherwise excluded, caused by

- (i) pollution or contamination which results from any Contingency hereby insured against
 - (ii) any Contingency hereby insured against which results from pollution or contamination.
- (e) Damage caused by pressure waves from aircraft or aerial devices.
- (2) any Damage whatsoever resulting directly or indirectly from or in connection with any of the following regardless of any other cause or event contributing concurrently or in any other sequence to the loss
- (a) Terrorism
 - (b) civil commotion in Northern Ireland
 - (c) any action taken in controlling preventing suppressing or in any way relating to (a) and/or (b) above.

Terrorism means

- (i) in respect of Damage occurring in England Wales and Scotland only (but not the territorial seas adjacent thereto as defined by the Territorial Sea Act 1987 nor the Isle of Man or the Channel Islands) acts of persons acting on behalf of or in connection with any organisation which carries out activities directed towards the overthrowing or influencing by force or violence of Her Majesty's government in the United Kingdom or any other government de jure or de facto
- (ii) in respect of Damage occurring in any territory not specified in (i) above any act or acts including but not limited to
 - the use or threat of force and/or violence and/or
 - harm or damage to life or to property (or the threat of such harm or damage) including but not limited to harm or damage by nuclear and/or chemical and/or biological and/or radiological means

caused or occasioned by any person(s) or group(s) of persons or so claimed in whole or in part for political religious ideological or similar purposes.

In any action suit or other proceedings where We allege that any Damage results from Terrorism as defined above and is therefore not covered under this Section the burden of proving that any such Damage is covered under this Section will be upon You.

- (3) We will not indemnify You in respect of Damage caused by riot and/or civil commotion unless these Contingencies are specified in The Schedule.

Conditions

The following conditions apply to this Section.

(Also refer to the Policy Conditions at the back of this policy booklet).

(1) Average

Where a Sum Insured is stated to be subject to average, this means that if at the time of Damage, the Sum Insured is less than the total value of the property, You will

- (a) be responsible for the difference
- (b) bear a proportionate share of the loss.

(2) Fire Extinguishing Appliances

If in relation to any claim for Damage by Contingency A, You have failed to fulfil the following condition You will lose Your right to indemnity or payment for that claim.

You must maintain all fire extinguishing appliances on The Premises so far as your responsibility extends, in proper working order.

(3) Our Rights

If Damage occurs which may lead to a claim We may

- (a) enter or take possession of the building or The Premises

Asset Protection Property Damage - Specified Contingencies

- (b) take possession of, or require to be delivered to Us, Property Insured which We will deal with in a reasonable manner

without incurring liability or reducing Our rights.

We will not pay for Damage if You or anyone acting on Your behalf

- (i) do not comply with Our requirements
- (ii) hinder or obstruct Us.

You are not entitled to abandon property to Us.

(4) Statutory Inspection of Plant

Any item of plant and machinery belonging to You or under Your control which requires to be examined to comply with any Statutory Regulations must be inspected in accordance with such Regulations.

Failure to comply with this will invalidate cover in respect of an explosion originating within and causing damage to the item of plant.

Property Damage - All Risks Section

Definitions

(Also refer to the Policy Definitions at the front of this policy booklet).

The following Definitions apply to this Section and shall keep the same meaning wherever they appear in the Section, unless an alternative definition is stated to apply.

Contingency Groups

- (a) fire, lightning explosion, aircraft, riot, civil commotion, strikers, locked out workers, persons taking part in labour disturbances and earthquake
- (b) malicious persons, storm, flood, escape of water from any tank, apparatus or pipe, impact
- (c) all other insured Damage other than any Additional Contingency or Theft Contingency if applicable.
- (d) Theft Contingency.

Damage

Accidental loss or destruction of or damage to the Property Insured.

Defined Contingency

fire

lightning

explosion

aircraft and other aerial devices or articles dropped from them

riot, civil commotion, strikers, locked out workers or persons taking part in labour disturbances

malicious persons other than thieves

earthquake

storm or flood

escape of water from any tank, apparatus or pipe

falling trees

impact

escape of fuel from any fixed oil heating installation.

Excess/Excesses

The amount or amounts shown in Your policy or The Schedule which We will deduct from each and every claim at each separate location and will be deducted after the application of Average. See Condition 1.

You will repay any such amount paid by Us.

Property Insured

Property insured as detailed in The Schedule.

Cover

We will indemnify You in respect of Damage occurring during the Period of Insurance at The Premises.

The Sum Insured under each Item other than Items applying solely to fees, rent, removal of debris, private dwelling houses, churches or buildings in course of erection is separately subject to Average. See Condition 1.

The maximum We will pay under this Section in any one Period of Insurance will not exceed

- (1) the Sum Insured on each Item

or

- (2) the Total Sum Insured

or

- (3) any other maximum amount payable or limit of liability specified in The Schedule.

Exceptions

The following exceptions apply to this Section.

(Also refer to the Policy Exceptions at the back of this policy booklet).

We will not indemnify You in respect of

- (1) Damage caused by or consisting of
 - (a) an existing or hidden defect

- (b) gradual deterioration or wear and tear
- (c) frost or change in the water table level
- (d) faulty design or faulty materials used in its construction
- (e) faulty workmanship, operating error or omission by You or any Employee

However We will indemnify You in respect of any subsequent Damage which results from a cause not otherwise excluded.

(2) Damage caused by or consisting of

- (a) (i) corrosion, rust or rot
- (ii) shrinkage, evaporation or loss of weight
- (iii) dampness or dryness
- (iv) scratching
- (v) vermin or insects
- (vi) mould or fungus

(b) change in

- (i) temperature
- (ii) colour
- (iii) flavour
- (iv) texture or finish

(c) nipple or joint leakage or failure of welds

(d) cracking, fracturing, collapse or overheating of a boiler, vessel, machine or apparatus in which internal pressure is due to steam only and any associated piping

(e) mechanical or electrical breakdown or derangement of the Property Insured.

However, We will indemnify You in respect of

- (i) Damage not otherwise excluded which itself results from a Defined Contingency or any other accidental cause
- (ii) any subsequent Damage which itself results from a cause not otherwise excluded.

(3) Damage caused by pollution or contamination

However, We will indemnify You in respect of Damage, not otherwise excluded, to the Property Insured caused by

- (a) pollution or contamination which results from a Defined Contingency
- (b) a Defined Contingency which results from pollution or contamination.

(4) Damage caused by or consisting of

(a) subsidence, ground heave or landslip unless resulting from fire, explosion, earthquake or escape of water from any tank, apparatus or pipe

(b) normal settlement of new structures

(c) acts of fraud or dishonesty

- (d) (i) disappearance
- (ii) unexplained or inventory shortage
- (iii) misfiling, misplacing of information or clerical error

(e) theft or attempted theft.

(5) Damage to a structure caused by its own collapse or cracking.

However, We will indemnify You in respect of such Damage if it results from a Defined Contingency and is not otherwise excluded.

(6) Damage to

(a) gates

(b) fences

(c) moveable property in the open

by

- (i) wind
- (ii) rain, hail, sleet or snow
- (iii) flood
- (iv) dust.

(7) (a) Damage by fire resulting from its' undergoing any process involving the application of heat

(b) Damage to that portion of any item caused by its' own self ignition, leakage of electricity, short circuiting, or over-running

(c) Damage resulting from its' undergoing any process of

- (i) production or packaging
- (ii) treatment, testing or commissioning
- (iii) servicing or repair.

However, We will indemnify You in respect of such Damage if it is caused by fire or explosion.

(8) Damage while any building is unoccupied or disused caused by escape of water as a result of freezing of any automatic sprinkler installation in The Premises

(9) Damage in respect of

- (a) glass not being fixed glass forming part of the structure of the building
- (b) china, earthenware, marble or other fragile objects (not including stock in trade).

However, We will indemnify You in respect of such Damage if it results from a Defined Contingency and is not otherwise excluded.

(10) Damage in respect of

- (a) vehicles licensed for road use including accessories on or attached to them
- (b) caravans or trailers
- (c) railway locomotives or rolling stock
- (d) watercraft or aircraft
- (e) property in the course of construction including materials for use in the construction
- (f) land, roads or pavements, piers, jetties, bridges, culverts or excavations
- (g) livestock
- (h) growing crops or trees

However, We will indemnify You in respect of Damage to such property if the property is specifically stated as insured in The Schedule and the Damage is not otherwise excluded.

(11) Damage

- (a) insured by any marine policy

(b) which would be insured under any marine policy if this policy did not exist

However, We will indemnify You in respect of Damage not otherwise excluded for any sum beyond the amount which would have been payable under the marine policy had this insurance not existed.

(12) Damage more specifically insured by You or on Your behalf.

(13) consequential loss or damage.

However, We will indemnify You in respect of rent when this cover is specified in The Schedule and the Damage is not otherwise excluded.

(14) Damage by pressure waves from aircraft or aerial devices.

(15) any Damage whatsoever resulting directly or indirectly from or in connection with any of the following regardless of any other cause or event contributing concurrently or in any other sequence to the loss

- (a) Terrorism
- (b) civil commotion in Northern Ireland
- (c) any action taken in controlling, preventing, suppressing or in any way relating to (a) and/or (b) above.

Terrorism means:

- (i) in respect of Damage occurring in England Wales and Scotland only (but not the territorial seas adjacent thereto as defined by the Territorial Seas Act 1987 nor the Isle of Man or the Channel Islands) acts of persons acting on behalf of or in connection with any organisation which carries out activities directed towards the overthrowing or influencing by force or violence of Her Majesty's government in the United Kingdom or any other government de jure or de facto
- (ii) in respect of Damage occurring in any territory not specified in (i) above any act or acts including but not limited to

- the use or threat of force and/or violence and/or
- harm or damage to life or to property (or the threat of such harm or damage) including but not limited to harm or damage by nuclear and/or chemical and/or biological and/or radiological means

caused or occasioned by any person(s) or group(s) of persons or so claimed in whole or in part for political religious ideological or similar purposes.

In any action suit or other proceedings where We allege that any Damage results from Terrorism as defined above and is therefore not covered by this Section the burden of proving that any such Damage is covered under this Section will be upon You.

(16) the Excess as stated in The Schedule.

Conditions

The following conditions apply to this Section.

(Also refer to the Policy Conditions at the back of this policy booklet).

(1) Average

Where a Sum Insured is stated to be subject to average, this means that if at the time of Damage, the Sum Insured is less than the total value of the property, You will

- (a) be responsible for the difference
- (b) bear a proportionate share of the loss.

(2) Fire Extinguishing Appliances

If in relation to any claim for Damage caused by or resulting from fire, You have failed to fulfil the following condition, You will lose Your right to indemnity or payment for that claim.

You must maintain all fire extinguishing appliances on The Premises, so far as your responsibility extends, in proper working order.

(3) Our Rights

If Damage occurs which may lead to a claim We may

- (a) enter or take possession of the building or The Premises
- (b) take possession of, or require to be delivered to Us, Property Insured which We will deal with in a reasonable manner

without incurring liability or reducing our rights.

We will not pay for Damage if You or anyone acting on Your behalf

- (i) do not comply with Our requirement
- (ii) hinder or obstruct Us

You are not entitled to abandon property to Us.

(4) Statutory Inspection of Plant

Any item of plant and machinery belonging to You or under Your control which requires to be examined to comply with any Statutory Regulations must be inspected in accordance with such Regulations.

Failure to comply with this will invalidate cover in respect of an explosion originating within and causing damage to the item of plant

Theft Contingency

We will indemnify You in respect of Damage at The Premises caused by theft or attempted theft.

We will not indemnify You in respect of Damage

- (a) caused by or consisting of acts of fraud or dishonesty
- (b) as a result of
 - (i) disappearance
 - (ii) unexplained or inventory shortage
 - (iii) misfiling, misplacing of information or clerical error
- (c) the Excess stated in The Schedule

Clauses

All of the following Clauses apply to the Property Damage - Specified Contingencies Section and/or Property Damage - All Risks Section if stated as insured in The Schedule.

Adjoining Buildings

In respect of Damage caused by subsidence, ground heave or landslip, You will notify Us immediately of any demolition, construction, erection, groundworks or excavation being carried out on any adjoining site. We will then have the right to vary the terms of or cancel this Cover.

Automatic Reinstatement of Sum Insured

The Sums Insured stated in The Schedule, will not be reduced by the amount of any claim unless We or You give notice to the contrary.

You must pay the additional premium required to reinstate the Sums Insured.

Basis of Claim Settlement - Reinstatement

Unless otherwise stated in The Schedule, in the event of Damage the basis upon which We will calculate the amount We will pay for any claim will be the reinstatement of the Property Insured lost, destroyed or damaged, subject to the following conditions:

- (1) If Property Insured under any Buildings, Blocks of Flats, Furniture, Machinery or Tenants alterations Item described in The Schedule, other than pedal cycles, personal items, rent or motor vehicles if insured, is lost or destroyed, We will pay for its rebuilding or replacement by similar property in a condition as good as, but not better than or more extensive than, its condition when new.

If such Property Insured is damaged, We will pay for replacement or repair of the damaged portion to a condition as good as, but not better or more extensive than, its condition when new.

However, We will not pay more than We would have done if the property had been completely destroyed.

- (2) The Property Insured may be replaced on another site and in a manner suitable to Your needs, but this must not increase Our liability.

- (3) All work must begin and be carried out as quickly as possible.
- (4) If, at the time of rebuilding or replacement, 85% of what it would have cost to replace the whole of the Property Insured under that Item, is greater than the Sum Insured at the time the Damage occurred, You will be liable to bear a proportionate share of the loss.

- (5) We will not pay under this Clause
 - (a) until You have incurred the cost of replacing or repairing the Property Insured
 - (b) if You, or someone acting on Your behalf have insured the property under another policy which does not have a similar basis of reinstatement
 - (c) if You do not comply with any of the terms of this Clause.

- (6) We will indemnify You in respect of Loss of Rent as insured under this Section resulting from the Building or any part of the Building
 - (a) generating the rent received
 - or
 - (b) for which rent is payable

being made unfit for The Business due to Damage insured by this Section.

The maximum amount that We will pay You under this clause will be the proportion of the Sum Insured which equals but does not exceed the proportion of the period of rent insured necessary to make the building fit for occupation.

Capital Additions

We will indemnify You in respect of loss destruction or damage to

- (1) any newly built and/or newly acquired building
- (2) alterations, additions and improvements to an insured building but not in respect of any appreciation in value

situated anywhere in England, Wales, Scotland, Northern Ireland, the Channel Islands or the Isle of Man.

Asset Protection Property Damage - Clauses

The maximum we will pay in respect of any one location under this Clause is

- (a) £2,000,000 in respect of any newly built and/or newly acquired building
- (b) £500,000 in respect of alterations, additions and improvements to the building

You must provide Us with details of these extensions as soon as possible but at least within six months and specifically insure such extensions with Us, from the date Our liability commenced and pay the appropriate additional premium.

Change of Occupancy

You must tell Us immediately if

- (1) any building stated in The Schedule becomes unoccupied or disused
- (2) any unoccupied or disused building stated in The Schedule, or any part of it becomes occupied.

Changing Locks

We will indemnify You in respect of the cost of changing locks at The Premises following loss of keys by theft or attempted theft from

- (1) The Premises
- (2) Your home
- (3) Your director's homes
- (4) Your authorised Employees homes

or while in Your custody or that of an Employee following theft involving violence or threat of violence to You or an Employee.

The maximum We will pay for any one loss is £2,500.

Construction Heating and Occupation of the Buildings

Unless otherwise stated in The Schedule the buildings are

- (1) constructed of brick, stone or concrete
- (2) roofed with slates, tiles, concrete, metal or asbestos

(3) heated by

- (i) low pressure hot water or steam
- (ii) oil fired space heaters fed from a fuel tank in the open
- (iii) overhead gas or electrical appliances
- (iv) gas or electric fires in offices only

or as expressly varied in accordance with details provided to Us.

(4) occupied for the sole purpose of The Business and otherwise only as a private dwelling.

Contents of Common Parts

This term includes contents and furnishings owned by You or for which You are responsible whilst contained in the common parts of the Property Insured.

We will not pay for

- (a) china or other fragile or brittle objects exceeding £1,000 any one article
- (b) computers and data processing equipment
- (c) curios, rare books, works of art or articles of antique furniture exceeding £1,000 in value any one article

unless specifically mentioned as insured in The Schedule.

Contractors' Interest

Where You are required to effect insurance on the Property Insured in the joint names of You and the contractor under the terms of a contract condition then the interest of the contractor in the Property Insured as joint Policyholder is hereby noted and You must provide Us with details of any single contract valued in excess of £250,000 prior to work commencing and pay an additional premium if required.

Damage to Grounds

We will indemnify You in respect of reasonable costs and expenses necessarily incurred in reinstating or repairing landscaped gardens and grounds, belonging to You or for which You are responsible, following Damage at The Premises.

We will not indemnify You in respect of

- (a) the cost of moving soil other than as necessary for surface preparation
- (b) the failure of trees, shrubs, plants or turf to become established
- (c) the failure of seeds to germinate
- (d) damage caused by disease, infection or application of chemicals

The maximum We will pay in respect of any one claim is £25,000.

Debris Removal

Unless separately insured under this Section, the Sum Insured for each Item, other than rent if insured, includes costs and expenses You incur, with Our consent, for

- (1) removal of debris
- (2) dismantling or demolishing
- (3) shoring up or propping

of the parts of the property which have suffered Damage insured under this Section.

We will not indemnify You in respect of costs and expenses

- (a) incurred in removing debris from anywhere other than the site of the Damage and the area immediately adjacent to it
- (b) arising from pollution or contamination of property not insured by this Section
- (c) more specifically insured.

Description of Property

In determining the Item under which property is insured, We will accept the description given in Your business records.

Drains

The Sum Insured for each Buildings and Machinery Item extends to include an amount necessarily and reasonably incurred by You, and which We agree to for cleaning and/or clearing of

- (1) drains

- (2) sewers

- (3) gutters

for which You are responsible, following Damage insured by this Section.

European Union and Public Authorities

Following Damage insured by this Section to any Item on Buildings, Blocks of Flats, Furniture, Machinery or Tenants alterations Item described in The Schedule, We will pay the additional cost of reinstating the Property Insured necessary to comply with any

- (1) European Union Legislation
- (2) Act of Parliament
- (3) Bye-Laws of any public authority.

We will not indemnify You in respect of

- (a) costs incurred
 - (i) in respect of Damage not insured by this Section
 - (ii) where notice was served on You before the Damage occurred
 - (iii) where an existing requirement must be completed within a stipulated period
 - (iv) in respect of property or parts of the property, other than foundations (unless foundations are specifically excluded) which have not suffered Damage
- (b) any charge or assessment arising from capital appreciation following compliance with any legislation or Bye-Law.

The reinstatement of the Property Insured

- (1) must begin and be carried out as quickly as possible
- (2) may be carried out on another site and in a manner suitable to Your needs but this must not increase Our liability.

If Our liability under this Section is reduced by the application of any terms or Conditions of this policy, Our liability under this Clause will similarly be reduced.

The maximum We will pay under this Clause in respect of any one Item is the Item Sum Insured.

Asset Protection Property Damage - Clauses

Gardening Equipment

We will indemnify You in respect of Damage to gardening equipment owned by You and used in connection with The Business at The Premises.

The maximum We will pay in respect of any one claim is £10,000.

Loss of Metered Utilities

We will pay for charges for which You are responsible, if water, gas or electricity is accidentally discharged from a metered system providing service to The Premises as a result of Damage insured under this Section.

The maximum that We will pay in respect of any one claim is £25,000.

Loss of Rent and Alternative Accommodation

We will indemnify You if a residence cannot be lived in or if access to it is denied as a result of Damage in respect of

- (1) (a) loss of rent, including ground rent and management charges, You should have received but have lost
 - (b) (i) the cost of reasonable alternative accommodation incurred by any owner or lessee if this is necessary
 - (ii) the cost of reasonable accommodation in kennels and/or catteries for dogs and/or cats belonging to any owner or lessee in residence, where such pets are not permitted in any alternative accommodation.
- (2) temporary storage of your furniture

The maximum We will pay in respect of any one claim is 20% of the Sum Insured on the building in which the residence is contained.

Non-Invalidation

The insurance by this Section will not be invalidated by any

- (1) act
- or
- (2) omission

or

- (3) alteration

either unknown to You or beyond Your control which increases the risk of Damage.

However, You must

- (a) notify Us immediately You become aware of any such act, omission or alteration

and

- (b) pay any additional premium required.

Other Interests

Subject to Your consent, the interest of all parties who wish to register an interest in the Cover by this Section will be noted provided that all such interests are notified to Us within 30 days of any Damage.

Professional Fees

The Sum Insured for each Buildings, Blocks of Flats or Machinery Item described in The Schedule, includes an amount for professional fees necessarily incurred in reinstating or repairing the Property Insured, following Damage insured by this Section.

We will not indemnify You in respect of fees

- (1) more specifically insured
- (2) incurred in preparing a claim.

Reinstatement to Match

Where the Property Insured has suffered Damage, You may replace, repair or restore the property with equivalent property which employs current technology, and replacement, repair or restoration with such property for the purposes of this Section shall not be regarded as being better or more extensive than when new. This Section further extends to include the replacement or modification of undamaged property insofar as it is necessary to adapt it to operate in conjunction with that property which has been replaced, repaired or restored provided that Our total liability is not increased beyond the amount that would otherwise have been payable for the replacement, repair or restoration of the property destroyed or damaged in its original form.

Asset Protection Property Damage - Clauses

When the Property Insured is damaged or destroyed in part only, We will not pay more than the amount representing the cost which We would pay for reinstatement if such property had been wholly destroyed.

Risk Protection Equipment Replacement Costs

We will indemnify You in respect of reasonable costs and expenses incurred in refilling, recharging or replacing any

- (1) portable fire extinguishing appliances
- (2) local fire suppression system
- (3) fixed fire suppression system
- (4) sprinkler installation
- (5) sprinkler heads

and having any fire and/or intruder alarms and closed circuit television equipment re-set

as a result of Damage as insured under this Section.

We will not indemnify You in respect of any costs and expenses recoverable from the maintenance company or fire service.

The maximum We will pay in respect of any one claim is £50,000.

Subrogation Waiver

In the event of a claim arising under this Section, We agree to waive any rights, remedies or relief to which We may be entitled by subrogation against

- (1) any company whose relationship to You is either a parent to subsidiary or subsidiary to parent as defined in, or within the meaning of the relevant Companies Act or Companies (N.I.) Order, current at the time of Damage
- (2) any company which is a subsidiary of a parent company of which You are a subsidiary as defined in, or within the meaning of the relevant Companies Act or Companies (N.I.) Order, current at the time of Damage
- (3) any tenant of Yours provided that
 - (a) the tenant or lessee contributes to the cost of insuring the Property Insured against the event which caused the Damage

- (b) the Damage did not result from a breach of the terms of the lease by the tenant or lessee
- (c) the Damage did not result from a criminal, fraudulent or malicious act of the tenant or lessee.

Temporary Removal for Cleaning or Renovation

We will indemnify You in respect of Damage insured by this Section other than to Stock and Materials in Trade, while temporarily removed for cleaning, renovation or repair or similar purposes

- (1) to another part of The Premises
- (2) to any other premises in England, Wales, Scotland, Northern Ireland, the Republic of Ireland, the Channel Islands and the Isle of Man including whilst in transit by road, rail or inland waterway.

The maximum We will pay is 10% of the Item Sum Insured after the deduction of the value of any building and Stock and Materials in Trade included within the Item insured.

We will not indemnify You in respect of

- (a) property insured elsewhere
- (b) Damage occurring elsewhere than at The Premises to motor vehicles or motor chassis licensed for normal road use
- (c) property removed for more than 90 consecutive days unless We agree a longer period in writing.

Trace and Access

We will pay reasonable costs and expenses incurred with Our consent

- (1) in locating the actual source of Damage
and
- (2) for repairs directly arising from (1)

caused by the escape of water from any tank, apparatus or pipe or leakage of fuel from any fixed oil heating installation, provided such Damage is insured by this Section.

Asset Protection Property Damage - Clauses

We will not indemnify You for costs or expenses incurred where Damage results solely from a change in the water table level.

The maximum We will pay in respect of any one claim is £50,000

Transfer of Interest

If at the time of Damage to a Building insured under this Section You have entered into a contract to sell Your interest in it but

- (1) the contract has not yet been completed
and
- (2) the Building has not yet been insured by or on behalf of the purchaser
and
- (3) the purchase is subsequently completed.

We will indemnify the purchaser to the extent that this Section insures that Building.

This will not affect either Your or Our rights and liabilities up to the date of completion of the purchase.

Value Added Tax

The insurance by this Section extends to include Value Added Tax paid by You (including 'self-supply' Value Added Tax where appropriate) which is not subsequently recoverable provided that

- (1) (a) Your liability for such tax arises solely as a result of the reinstatement or repair of the buildings following Damage

(b) We have paid or have agreed to pay for such Damage

(c) if any payment by Us in respect of the reinstatement or repair of such Damage is less than the actual cost of reinstatement or repair, any payment under this Clause resulting from that Damage will be reduced in like proportion
- (2) Your liability for such tax does not arise from the replacement building having greater floor area than or being better or more extensive than the destroyed or damaged building

- (3) where an option to reinstate on another site is exercised, Our liability under this Clause will not exceed the amount of tax that would have been payable had the building been rebuilt on its original site

- (4) Our liability under this Clause will not include amounts payable by You as penalties or interest for non-payment or late payment of tax

The following amendments are made to this Policy in respect of this Clause only

A for the purposes of any Condition of Average, rebuilding costs will be exclusive of Value Added Tax

B Our liability may exceed the Sum Insured where such excess is solely in respect of Value Added Tax.

Workmen

Repairs and minor structural alterations may be carried out at The Premises without affecting the Cover.

Additional Clause List A

The following Additional Clauses only apply to the Property Damage - Specified Contingencies Section and/or the Property Damage - All Risks Section if stated in The Schedule.

A Day One (Non Adjustable)

For each item of Property Insured to which this clause applies (as stated in The Schedule),

- (1) the first and annual premiums are based upon the Declared Value as stated in The Schedule.

Declared Value shall mean

Your assessment of the cost of reinstatement of the Property Insured arrived at in accordance with paragraph (1) of the Basis of Settlement - Reinstatement Clause at the level of costs applying at the start of the Period of Insurance (ignoring inflationary factors which may operate subsequently) together with an allowance for

- (a) the additional cost of reinstatement to comply with
- (i) European Union Legislation
 - (ii) Act of Parliament
 - (iii) Bye-Laws of any public authority
- (b) professional fees
- (c) debris removal costs.

The Declared Value incorporated in each Item is stated in The Schedule.

- (2) You must notify Us of the Declared Value at the start of each Period of Insurance.

If You fail to notify Us of the Declared Value at the start of any Period of Insurance, We will use the last Declared Value notified to Us for the following Period of Insurance.

- (3) paragraphs (4) and (5) of the Basis of Settlement - Reinstatement Clause are restated as follows

- (4) if, at the time of the Damage, the Declared Value is less than the cost of reinstatement of the Property Insured, arrived at in accordance with paragraph (1) of this Clause, at the start of the Period of Insurance, Our liability for any Damage will be limited to that proportion which the Declared Value bears to the cost of reinstatement of the Property Insured arrived at in accordance with paragraph (1) of this Clause.

- (5) We will not pay under this Clause
- (a) until You have incurred the cost of replacing or repairing the property
 - (b) if You, or someone acting on Your behalf, have insured the property under another policy which does not have the same basis of reinstatement
 - (c) if You do not comply with any of the provisions of this Clause.

However the Sums Insured will be limited to 108% of the Declared Values stated in The Schedule.

- (4) the maximum We will pay in respect of each separate location subject to this Clause is as stated in The Schedule.

B Day One (Adjustable)

For each item of Property Insured to which this Clause applies (as stated in The Schedule),

- (1) the first and annual premiums are based upon the Declared Value as stated in The Schedule.

Declared Value shall mean

Your assessment of the cost of reinstatement of the Property Insured arrived at in accordance with paragraph (1) of the Basis of Settlement - Reinstatement Clause at the level of costs applying at the start of the Period of Insurance (ignoring inflationary factors which may operate subsequently) together with allowance for

- (a) the additional cost of reinstatement to comply with

Asset Protection Property Damage - Additional Clause List A

- (i) European Union Legislation
- (ii) Act of Parliament
- (iii) Bye-Laws of any public authority

(b) professional fees

(c) debris removal costs.

The Declared Value incorporated in each item is stated in The Schedule.

(2) You must notify Us of the Declared Value at the start of each Period of Insurance.

If You fail to notify Us of the Declared Value at the start of any Period of Insurance, We will use the last Declared Value notified to Us for the following Period of Insurance.

(3) the premium is provisional.

On expiry of each Period of Insurance the premium will be adjusted by 50% of the difference between

(a) the provisional premium at the start of the period

and

(b) the premium calculated at the terms which applied during the period under adjustment based on the Declared Value for the following Period of Insurance.

(4) for the purpose of paragraph (3) of this Clause

You must provide the Declared Value if the

(a) policy is cancelled or not renewed, in accordance with paragraph (1) of this clause, at the level of costs applying at the date of cancellation or non-renewal

(b) property has not been reinstated following Damage as though the property had not suffered Damage.

Where no declaration is made by You, We will charge You an additional premium not exceeding 4% of the provisional premium paid.

(5) paragraphs (4) and (5) of the Basis of Settlement - Reinstatement Clause are restated as follows

(4) if, at the time of the Damage, the Declared Value is less than the cost of reinstatement of the Property Insured, arrived at in accordance with paragraph (1) of this Clause, at the start of the Period of Insurance, Our liability for any Damage will be limited to that proportion which the Declared Value bears to the cost of reinstatement of the Property Insured arrived at in accordance with paragraph (1) of this Clause.

(5) We will not pay under this Clause

(a) until You have incurred the cost of replacing or repairing the property

(b) if You, or someone acting on Your behalf, have insured the property under another policy which does not have the same basis of reinstatement

(c) if You do not comply with any of the provisions of this Clause.

However the Sums Insured will be limited to 104% of the Declared Values stated in The Schedule.

(6) each Item includes

(a) newly built and/or newly acquired buildings and/or machinery alterations, additions and

(b) improvements to buildings and/or contents anywhere in England, Wales, Scotland, Northern Ireland, the Channel Islands and the Isle of Man.

The maximum We will pay You in respect of any one location is as stated in The Schedule

Any other extension to each applicable Item of this Section relating to Capital Additions as stated in 6 (a) and 6 (b) above is cancelled.

(7) the maximum We will pay in respect of each separate location subject to this Clause is stated in The Schedule.

J Deductible

We will deduct the amount of the deductible stated in The Schedule in respect of each and every claim at each separate location as calculated after the application of all other terms of this Section.

We may not indemnify You in respect of any claim and/or may charge You an additional premium if You arrange insurance in respect of the deductible.

M Requirements

If in relation to any claim in respect of Damage by any insured contingency, You have failed to implement the requirements set against that contingency in the Schedule of Requirements, within the timescales specified, You will lose Your right to indemnity or payment for that claim.

N Intruder Alarm System

For the purpose of this Additional Clause only the following definitions apply

Damage

Damage means

- (a) where Property Damage - Specified Contingencies is insured, loss or destruction of or damage to the Property Insured caused by any of Contingencies A, B, C or under the Theft Contingency
- (b) where Property Damage - All Risks is insured, loss or destruction of or damage to the Property Insured caused by fire, explosion, riot, civil commotion, strikers, locked out workers or persons taking part in labour disturbances, malicious persons other than thieves, or under the Theft Contingency.

Intruder Alarm System

An electrical installation to detect and indicate the presence, entry or attempted entry of an intruder into Protected Premises.

Protected Premises

The Premises or those portions of The Premises protected by the Intruder Alarm System.

Responsible Person

You or any person authorised by You to be responsible for the security of The Premises.

Keyholder

You or any person or keyholding company authorised by You who must be available at all times to accept notification of faults or alarm signals relating to the Intruder Alarm System, attend, and allow access to The Premises.

If in relation to any claim for Damage in this Additional Clause You have failed to fulfil any of the following conditions, You will lose Your right to indemnity or payment for that claim.

While the premises are unattended You must ensure that

- (1) The Premises are protected by an Intruder Alarm System and means of communication used to transmit signals from such an Intruder Alarm System designed, installed and maintained as agreed by Us.
- (2) the Protected Premises must not be left without at least one Responsible Person in attendance
 - (i) unless the Intruder Alarm System is set in its entirety with all means of communication used to transmit signals in full operation
 - (ii) if the police have withdrawn their response to alarm callsunless We agree otherwise.
- (3) in the event of notification of any activation of the Intruder Alarm System or interruption of any of the means of communication during any period that the Intruder Alarm System is set, a Keyholder shall attend The Premises as soon as reasonably possible, in order to confirm the security of The Premises and reset the Intruder Alarm System in its entirety. If the Intruder Alarm System cannot be reset in its entirety or all the means of communication used to transmit signals are not in full operation, a Keyholder must remain at The Premises unless We agree otherwise in writing.

(4) You shall advise Us as soon as possible, and in any event not later than 10.00am on Our next working day,

- (i) that police attendance in response to alarm signals/calls from the Intruder Alarm System may be withdrawn or the level of response reduced or delayed
- (ii) of notice from a Local Authority or Magistrate imposing any requirement for abatement of nuisance
- (iii) that the Intruder Alarm System and the means of communication used to transmit signals from such installation cannot be returned to or maintained in full working order

and You must comply with any of Our subsequent requirements.

(5) no alteration or substitution of

- (i) any part of the Intruder Alarm System
- (ii) the structure of The Premises or changes to the layout of The Premises which would affect the effectiveness of the Intruder Alarm System
- (iii) the means of communication used to transmit signals from the Intruder Alarm System
- (iv) the procedures agreed with Us for police or any other response to any activation of the Intruder Alarm System
- (v) the maintenance contract

shall be made without Our written agreement.

(6) You and each Keyholder must maintain secrecy of codes and security of keys and setting/unsetting devices for the operation of the Intruder Alarm System. All keys and other setting/unsetting devices for the Intruder Alarm System must be removed from The Premises when they are left unattended.

(7) the Intruder Alarm System shall be maintained in full and efficient working order under a contract to provide both corrective and preventative maintenance with the installing company or other such company, as agreed by Us.

(8) You will appoint at least two Keyholders and lodge written details (which must be kept up to date) with the alarm company contracted to maintain the Intruder Alarm System, and with the police if they so require.

O Failure of Tenants Insurances

We will indemnify You in respect of loss destruction or damage to any building owned by You in England, Wales, Scotland, Northern Ireland, the Channel Islands or the Isle of Man, for which (by the terms of an agreement with You) the tenant, lessee or other occupier of the building, has an obligation to insure but has failed to maintain in force such insurance.

The maximum We will pay in respect of this Additional Clause is £1,000,000 during the Period of Insurance.

You must advise Us in writing immediately You become aware that such insurance is not in force and pay the appropriate premium due for the period such insurance is not effected.

You must obtain written confirmation from the tenant, lessee, or occupier, and their Insurers, at the inception of any such agreement that insurance is in force, providing at least the extent of cover provided by this Policy, and also carry out an annual check that such insurance is in force for all such properties.

R Privity of Contract

We will indemnify You in respect of all such sums as You become legally liable to pay following Damage, and pay as indemnity to tenants in respect of repair or reinstatement of premises previously owned but which are no longer Your property and where the current owner has failed to maintain adequate insurance cover, subject to the terms and conditions of this Policy.

Conditions

- (a) You must take all reasonable and appropriate steps to obtain release from Your liabilities under the covenants to insure such property on its disposal.
- (b) The maximum We will pay under this Additional Clause is £2,000,000 during the Period of Insurance.

We will not indemnify You in respect of

- (i) contribution in respect of any more particular insurance effected by any succeeding owner or tenant or sub-tenant
- (ii) any occurrence happening seven years before the start date of the current Period of Insurance.

Asset Protection Property Damage - Additional Clause List A

S Inadvertent Failure to Insure

We will indemnify You in respect of loss destruction or damage to

- (1) any newly built and/or newly acquired building
- (2) alterations, additions and improvements to an insured building but not in respect of any appreciation in value

which You have an obligation to insure whether owned or leased by You, but which have inadvertently been left uninsured.

The maximum We will pay in respect of any one location under this Clause is

- (a) £2,000,000 in respect of any newly built and/or newly acquired building
- (b) £500,000 in respect of alterations, additions and improvements to the building

situate anywhere in England, Wales, Scotland, Northern Ireland, the Channel Islands or the Isle of Man.

You must advise Us in writing immediately You become aware of a building inadvertently left uninsured and pay the appropriate premium due from the date Our liability commenced.

You must carry out, at not less than twelve month intervals, a check of all properties owned or leased by You and for which You are responsible to ensure that effective insurance is in force on each of them.

Additional Clause List B

All of the following Additional Clauses only apply to the Property Damage - Specified Contingencies Section and/or Property Damage - All Risks Section if stated in The Schedule.

Automatic Fire Alarm

When a discount has been allowed in consideration of an automatic fire alarm installation, if You have failed to fulfil any of the following conditions the discount may be removed and an additional premium charged to You.

You must

- (1) notify Us immediately
 - (a) if the automatic fire alarm is removed or permanently out of use
 - (b) or disconnections or failures of the system or parts of it that are likely to leave areas unprotected for 12 hours or more
 - (c) of any problems found as a result of maintenance.
- (2)
 - (a) keep in force a contract with a company acceptable to Us to service and maintain the system in proper working order
 - (b) carry out all inspections and maintenance in accordance with Norwich Union Recommendations for Automatic Fire Alarm Installations.

Automatic Sprinkler Systems - Parts A, B and C

If in relation to any claim for Damage caused by fire You have failed to fulfil any of the following conditions, You will lose Your right to indemnity or payment for that claim.

When a discount has been allowed in consideration of an automatic sprinkler installation if You have failed to fulfil any of the following conditions, the discount may be removed and an additional premium charged to You.

Part A

You must

- (1) give Us advance notice, in writing, if any part of the system is to be altered, repaired or rendered inoperative.
- (2) tell Us immediately by telephone or facsimile in the event of any emergency and take precautions as advised by Us.
- (3) allow Us to have access to The Premises at all times to inspect or witness the testing of the system.

Part B

You must carry out

- (1) the following tests, checks or inspections at weekly intervals and promptly rectify any defects, faults or shortcomings revealed by such tests, checks and inspections
 - (a) a test of each installation alarm gong, recording the time taken for the alarm to sound.
 - (b) an inspection to ensure that all
 - (i) installation main stop valves
 - (ii) incoming water supply stop valves
 - (iii) subsidiary stop valvesare fully opened and secured by means of a suitable strap and padlock.
- (2) a test to establish the condition of
 - (a) the circuit between the alarm switch and the control unit
 - (b) the connection with the
 - (i) public fire station
 - or
 - (ii) alarm receiving centre
 - or
 - (iii) public fire brigade controlWhere the circuit is not continuously monitored these tests must be carried out each working day.
 - (c) the batteries.

A maintenance contract and a half yearly inspection of this signalling system must be kept in force with approved engineers.

Asset Protection Property Damage - Additional Clause List B

(3) a check of any alternate or dry installation valves for correct air pressure and settings, including

- (a) accelerators
- (b) exhausters
- (c) air compressors
- (d) ancillary valves.

(4) a test of the automatic, and where provision has been made, the manual starting of the sprinkler water supply pump(s) ensuring that any diesel driven pump(s) is allowed to run for a period of not less than 30 minutes.

(5) a check of the electrically driven pump(s) to ensure that all

- (a) isolators are correctly set
- (b) circuit breakers are correctly set
- (c) electrical supply phase indicators are illuminated.

(6) a check of all the diesel driven pump(s)

- (a) engine oil level
- (b) fuel tank content
- (c) internal coolant circuits
- (d) battery electrolyte level
- (e) battery charger
- (f) oil hoses
- (g) water hoses
- (h) oil coolers
- (i) exhaust systems
- (j) turbo chargers
- (k) drive belt tensions.

Where replenishment or rectification is required this shall be carried out immediately on conclusion of the tests.

(7) (a) a check of the

- (i) air pressure tank water level
- (ii) air pressure

(b) a test of the air and water charging equipment.

(8) a check

- (a) of the water storage tank(s) water level
- (b) of the automatic refilling mechanism
- (c) that incoming supply valves are correctly set
- (d) that incoming supply valves are functional and that any frost precautions are in operation.

Part C

You must display prominently at each sprinklered storage area a notice of the terms agreed with Us which specifies

- (1) the description of goods which may be stored
- (2) the type of storage
- (3) the maximum height of storage
- (4) the minimum permitted clearance between goods stored and the sprinkler deflectors

and comply with the terms of the notice.

Household Goods Clause

The following Household Goods Clause only applies to the Property Damage - Specified Contingencies Section and/or Property Damage - All Risks Section if stated in The Schedule.

The Property Insured by the Item on Household Goods and Personal Effects is more fully described as

Household Contents and appliances, valuables and works of art, clothing, personal effects and other effects including Money up to £250 or 5% of the Item Sum Insured, whichever is the lower amount,

belonging to

- (1) You or for which You are responsible
- (2) members of Your family permanently residing with You
- (3) Your domestic employees situated
 - (a) in the private dwelling stated in The Schedule
 - (b) in the open within the boundary of the private dwelling specified in The Schedule up to £100.

We will not indemnify You in respect of

- (a) any one item other than furniture and household appliances for any amount in excess of £500 or 10% of the Item Sum Insured, whichever is the lower amount
- (b) property more specifically insured by You or on Your behalf
- (c) securities, certificates, computer records and documents
- (d) vehicles licensed for road use including accessories on or attached to them
- (e) caravans or trailers
- (f) watercraft or aircraft
- (g) livestock or pets
- (h) interior decorations.

Temporary Removal

We will indemnify You in respect of Damage insured under this Clause whilst temporarily removed including whilst in transit to and from

- (1) anywhere in England, Wales, Scotland, Northern Ireland, the Republic of Ireland, the Channel Islands and the Isle of Man
- (2) any other country within the European Union.

The maximum We will pay is 15% of the item Sum Insured.

We will not indemnify You in respect of

- (a) property removed for sale or exhibition
- (b) property kept in storage.

European Union and Public Authority Clauses

The following clauses only apply to the Property Damage - Specified Contingencies Section and/or Property Damage - All Risks Section if stated in The Schedule.

K European Union and Public Authorities - Undamaged Property

The European Union and Public Authorities clause contained in the Clauses is cancelled and replaced by the following Clause

European Union and Public Authorities including Undamaged Property

Following Damage insured by this Section to any Buildings, Blocks of flats, Furniture, Machinery or Tenants alterations Item described in The Schedule, We will pay the additional cost of reinstating the Property Insured including any undamaged portions necessary to comply with any

- (1) European Community legislation
- (2) Act of Parliament
- (3) Bye-Laws of any public authority.

We will not indemnify You in respect of

- (a) costs incurred
 - (i) in respect of Damage not insured by this Section
 - (ii) where notice was served upon You before the Damage occurred
 - (iii) where an existing requirement must be completed within a stipulated period
 - (iv) in respect of any building or contents which have not suffered Damage insured by this Section
- (b) any charge or assessment arising from capital appreciation following compliance with any legislation or Bye-Law.

The reinstatement of the Property Insured

- (a) must begin and be carried out as quickly as possible
- (b) may be carried out on another site and in

a manner suitable to Your needs but this must not increase Our liability.

If Our liability under this Section is reduced by the application of any terms or conditions of this policy, Our liability under this clause will similarly be reduced.

The maximum We will pay under this Clause in respect of

- (a) Property Insured which has suffered Damage is the Sum Insured
- (b) undamaged portions of Property Insured other than foundations is 15% of the amount We would have been liable to pay if the Property Insured by the item at The Premises where Damage occurred had been completely destroyed.

L European Union and Public Authorities - Undamaged Property and Sprinklers

The European Union and Public Authorities clause contained in the Clauses is cancelled and replaced by the following clause

European Union and Public Authorities including Undamaged Property and Sprinklers

Following Damage insured by this Section to any Buildings, Blocks of flats, Furniture, Machinery or Tenants alterations Item described in The Schedule, We will pay

- (1) the additional cost of reinstating the Property Insured including any undamaged portions necessary to comply with any
 - (a) European Community legislation
 - (b) Act of Parliament
 - (c) Bye-Laws of any public authority.
- (2) Where We require You to comply with current LPC Rules for Automatic Sprinkler Installations, the additional cost of reinstating water supply equipment which
 - (a) conformed to previous LPC Rules
 - (b) conformed to current LPC Rules when installed but fails to conform to subsequent amendments to those rules.

Asset Protection - Property Damage

We will not indemnify You in respect of

- (a) costs incurred
 - (i) in respect of Damage not insured by this Section
 - (ii) where notice was served upon You before the Damage occurred
 - (iii) where an existing requirement must be completed within a stipulated period
 - (iv) in respect of any building or contents which have not suffered Damage insured by this Section
- (b) any charge or assessment arising from capital appreciation following compliance with legislation.

The reinstatement of the Property Insured

- (a) must begin and be carried out as quickly as possible
- (b) may be carried out on another site and in a manner suitable to Your needs but this must not increase Our liability.

If Our liability under this Section is reduced by the application of any terms or conditions of this Policy, Our liability under this Clause will similarly be reduced.

The maximum We will pay under this Clause in respect of

- (a) Property Insured which has suffered Damage is the Sum Insured
- (b) undamaged portions of Property Insured other than foundations but including water supply equipment is 15% of the amount We would have been liable to pay if the Property Insured by the item at The Premises where Damage occurred had been completely destroyed.

Additional Contingencies

This Section extends to include the following Additional Contingencies, only if stated in The Schedule.

A Subsidence

We will indemnify You in respect of Damage at The Premises caused by subsidence or ground heave of the site of the Property Insured or landslip.

We will only indemnify You in respect of Damage to

- (a) forecourts, car parks, driveways, footpaths, swimming pools, terraces or patios
- (b) walls, gates, hedges or fences
- (i) if such property is specifically insured by this Section and
- (ii) if Damage also occurs to the building to which such property applies and that building is insured by this Section.

We will not indemnify You in respect of

- (1) Damage caused by
 - (a) collapse, cracking, shrinking or settlement of any building
 - (b) coastal or river erosion
 - (c) defective design or inadequate construction of foundations
 - (d) demolition, structural alteration or repair
 - (e) settlement or movement of made up ground.

- (2) Damage as a result of movement of solid floor slabs.

However, We will indemnify You in respect of Damage not otherwise excluded if there is Damage to the foundations beneath the exterior walls of The Premises at the same time.

- (3) the Excess stated in The Schedule.

B Underground Services

Where We provide indemnity in respect of Your buildings, or You are liable as tenant, We will indemnify You in respect of accidental damage to underground

- (a) pipes

- (b) cables

which extend from the buildings to the public mains.

We will not indemnify You in respect of

- (1) the cost of maintenance
- (2) damage caused by
 - (a) (i) gradual deterioration or wear and tear
 - (ii) corrosion, rust, rot, mould or fungus
 - (iii) vermin or insects
 - (iv) atmospheric or climatic conditions
 - (v) normal settlement or shrinkage
- (b) faulty workmanship, defective design or the use of defective materials
- (3) the Excess stated in The Schedule.

Additional Contingency

This Section extends to include the following Additional Contingency, only if stated in The Schedule.

A Subsidence

We will indemnify You in respect of Damage at The Premises caused by Subsidence or ground heave of the site of the Property Insured or landslip.

We will only indemnify You in respect of Damage to

- (a) forecourts, car parks, driveways, footpaths, swimming pools, terraces or patios
- (b) walls, gates, hedges or fences
- (i) if such property is specifically insured by this Section and
- (ii) if Damage also occurs to the building to which such property applies and that building is insured by this Section.

We will not indemnify You in respect of

- (1) Damage caused by
 - (a) collapse, cracking, shrinking or settlement of any building
 - (b) coastal or river erosion
 - (c) defective design or inadequate construction of foundations
 - (d) demolition, structural alteration or repair
 - (e) settlement or movement of made up ground.
- (2) Damage as a result of movement of solid floor slabs.

However, We will indemnify You in respect of Damage not otherwise excluded if there is Damage to the foundations beneath the exterior walls of The Premises at the same time.
- (3) the Excess stated in The Schedule.

Additional Conditions

The following additional conditions only apply to the Property Damage - Specified Contingencies Section and/or Property Damage - All Risks Section if the letter set against them appears in The Schedule.

(Also refer to the Conditions contained in these Sections and the Policy Conditions at the back of this policy booklet).

A Waste (Oily/Greasy) - Storage and Weekly Removal

If in relation to any claim You have failed to fulfil any of the following conditions, You will lose Your right to indemnity or payment for that claim.

You must

- (a) keep all oily and/or greasy waste and all used cleaning cloths, which remain in the buildings outside of normal working hours, in metal receptacles with metal lids
- (b) remove the contents of such metal receptacles from the buildings at least once a week.

B Waste (Combustible Trade/Refuse) - Nightly Removal

If in relation to any claim You have failed to fulfil any of the following conditions, You will lose Your right to indemnity or payment for that claim.

You must

- (a) sweep up all combustible trade waste and refuse every day
- (b) remove all combustible trade waste and refuse from the buildings every night.

C Waste (Combustible Trade/Refuse) - Storage and Weekly Removal

If in relation to any claim You have failed to fulfil any of the following conditions, You will lose Your right to indemnity or payment for that claim.

You must

- (a) sweep up all combustible trade waste and refuse every day

- (b) keep all such waste and refuse in bags or bins and remove it from the buildings at least once a week.

D Waste (Sawdust/Shavings/Other Refuse) - Nightly Removal

If in relation to any claim You have failed to fulfil any of the following conditions, You will lose Your right to indemnity or payment for that claim.

You must

- (a) sweep up all sawdust, shavings and other refuse every day
- (b) remove all sawdust, shavings and other refuse from the buildings every night.

E Waste (Oily/Greasy/Combustible) - Storage

If in relation to any claim You have failed to fulfil any of the following conditions, You will lose Your right to indemnity or payment for that claim.

You must keep all oily and/or greasy waste and used cleaning cloths and all other combustible trade waste which remain in the buildings outside of working hours in metal receptacles with metal lids.

F Firebreak Doors & Shutters

If in relation to any claim You have failed to fulfil any of the following conditions, You will lose Your right to indemnity or payment for that claim.

You must

- (a) close all firebreak doors and shutters outside of business hours
- (b) keep all firebreak doors and shutters in efficient working order.

G Portable Space Heaters

If in relation to any claim You have failed to fulfil any of the following conditions, You will lose Your right to indemnity or payment for that claim.

You must

- (a) not place portable space heaters

- (i) where they are liable to be overturned or suffer mechanical damage
 - (ii) where flammable atmospheres exist
 - (iii) on combustible surfaces
- (b) keep portable space heaters clear of combustible materials
- (c) maintain a clear space of at least one metre around the portable space heater by using a non-combustible guard.

H Premises Inspection

If in relation to any claim You have failed to fulfil any of the following conditions, You will lose Your right to indemnity or payment for that claim.

You must

- (a) examine the building for any smoking/ smouldering materials at the close of each working day
- (b) place any smoking/smouldering materials found in non-combustible receptacles
- (c) remove the contents of such receptacles daily from the buildings
- (d) maintain a daily log of examinations
- (e) carry out a weekly management check on the daily log of examinations.

J Deep Frying and Cooking Equipment

If in relation to any claim for Damage caused by or resulting from fire, You have failed to fulfil any of the following conditions, You will lose Your right to indemnity or payment for that claim.

You must ensure that

- (a) all deep frying and cooking equipment is installed, operated and maintained in accordance with the manufacturers' instructions
- (b) all deep frying equipment is fitted with a thermostat which prevents the temperature of fat or oil exceeding 205 degrees Centigrade (401 degrees Fahrenheit)

- (c) all deep frying and cooking equipment, including flues and exhaust ducting, is fixed and not in contact with combustible materials
- (d) all extraction hoods, canopies, filters and grease traps are cleaned at least every month
- (e) the entire internal length of all flues and extraction ducting, including extraction motors and fans, are cleaned at least every six months
- (f) suitable fire extinguishers and/or blankets are kept close to the equipment and cooking areas and staff are trained to use them
- (g) during deep frying and cooking operations no equipment is left unattended or unsupervised.

K Waste (Oily/Greasy/Combustible) - Storage and Weekly Removal

If in relation to any claim You have failed to fulfil any of the following conditions, You will lose Your right to indemnity or payment for that claim.

You must

- (a) keep all oily and/or greasy wipes and cloths and all combustible trade waste which remain in the buildings outside of working hours in metal receptacles with metal lids
- (b) remove the contents of the receptacles from the buildings at least once a week
- (c) store all such waste in non-combustible receptacles with non-combustible lids, when all such waste is stored outside of the buildings.

L Waste (Combustible Trade/Refuse) - Storage and Weekly Removal

If in relation to any claim You have failed to fulfil any of the following conditions, You will lose Your right to indemnity or payment for that claim.

You must

- (a) sweep up all combustible trade waste and refuse every day

- (b) keep all such waste and refuse in bags or bins and remove it from the buildings at least once a week
- (c) store all such waste in non-combustible receptacles with non-combustible lids, when all such waste is stored outside of the buildings.

M Waste (Combustible Trade/Refuse) - Storage and Nightly Removal

If in relation to any claim You have failed to fulfil any of the following conditions, You will lose Your right to indemnity or payment for that claim.

You must

- (a) sweep up all combustible trade waste and refuse every day
- (b) remove all combustible trade waste and refuse from the buildings every night
- (c) store all such waste in non-combustible receptacles with non-combustible lids, when all such waste is stored outside of the buildings.

N Outside Storage - Locked Receptacles

If in relation to any claim for Damage, when waste is stored outside of the buildings, You have failed to fulfil any of the following conditions, You will lose Your right to indemnity or payment for that claim.

You must

- (a) store all such waste in non-combustible receptacles with non-combustible lids
- (b) such receptacles must be securely locked outside of business hours.

P Outside Storage

If in relation to any claim for Damage, when waste is stored outside of the buildings, You have failed to fulfil any of the following conditions, You will lose Your right to indemnity or payment for that claim.

You must

- (a) secure all such waste in a secure waste disposal area at least 10 metres away from any buildings
- or
- (b) store all such waste in a designated storage building pending removal from The Premises
- (c) Securely lock all such waste disposal area(s) or building(s) outside of business hours.

Q Unoccupied Premises - Non Sprinklered

If in relation to any claim for Damage in respect of any unoccupied or disused buildings, You have failed to fulfil any of the following conditions, You will lose Your right to indemnity or payment for that claim.

You must

- (a) carry out internal and external inspections of the buildings at least every 7 days
 - (i) maintain a weekly log of such inspections
 - (ii) as soon as possible, repair or arrange to be repaired, any defects found
 - (iii) carry out a monthly management check of the weekly inspections log.
- (b) remove all waste, combustible materials and gas bottles, either within or outside the buildings, from The Premises
- (c) securely lock all external doors, close and secure all windows, and secure and seal all letter boxes and openings
- (d) turn off all sources of power, fuel and water at the mains and wherever possible, chain and padlock the isolation valves

However, where the buildings are protected by an Intruder Alarm System, You must provide sufficient power to operate the system.

- (e) advise Us immediately if the buildings are to be occupied by contractors for renovation, alteration or conversion purposes or if the buildings are to become occupied or used.

R Unoccupied Premises - Sprinklered

If in relation to any claim for Damage in respect of any unoccupied or disused buildings, You have failed to fulfil any of the following conditions, You will lose Your right to indemnity or payment for that claim.

You must

- (a) carry out internal and external inspections of the buildings at least every 7 days
 - (i) maintain a weekly log of such inspections
 - (ii) as soon as possible, repair or arrange to be repaired, any defects found
 - (iii) carry out a monthly management check of the weekly inspections log.
- (b) remove all waste, combustible materials and gas bottles, either within or outside the buildings, from The Premises
- (c) securely lock all external doors, close and secure all windows, and secure and seal all letter boxes and openings
- (d) turn off all sources of power, fuel and water at the mains and wherever possible, chain and padlock the isolation valves

However

- (i) where the buildings are protected by an Intruder Alarm System, You must provide sufficient power to operate the system
- (ii) where the buildings are protected by a wet sprinkler installation, provide sufficient heat to prevent freezing or bursting of the sprinkler installation.

- (e) advise Us immediately if the buildings are to be occupied by contractors for renovation, alteration or conversion purposes or if the buildings are to become occupied or used.

S Stock Storage - Basements and Ground Floors

If in relation to any claim You have failed to fulfil the following condition You will lose Your right to indemnity or payment for that claim.

You must ensure that all stock stored in basements and/or on the ground floors of The Premises is stored at least 75mm above floor level.

T Stock Storage - Basements only

If in relation to any claim You have failed to fulfil the following condition You will lose Your right to indemnity or payment for that claim.

You must ensure that all stock stored in basements of The Premises is stored at least 75mm above floor level.

Money and Assault Section

Definitions

(Also refer to the Policy Definitions at the front of this policy booklet).

The following definitions apply to this Section and shall keep the same meaning wherever they appear in the Section, unless an alternative definition is stated as applying.

Bodily Injury

Bodily injury by violent and visible means, which directly and independently of any other cause, results in death or disablement.

Business Hours

Your normal working hours and any other period during which You or one of Your directors, principals or Employees, entrusted with Money are on The Premises in connection with The Business.

Loss of Limb

- (1) Severance at or above the wrist or ankle
or
- (2) Total and permanent loss of use of a hand, arm, foot or leg.

The Premises

The Premises stated in the Property Damage Sections of The Schedule unless varied by endorsement.

Part A - Money

Cover

We will indemnify You in respect of

- (1) loss of Money, up to the Limit Any One Loss stated in The Schedule, which
 - (a) belongs to You
or
 - (b) You are responsible forin connection with The Business while

- (i) in transit
- (ii) in the custody of collectors for 24 hours from the time they receive it or until the next working day whichever is later
- (iii) on contract sites while You or Your Employees are working there
- (iv) on The Premises
- (v) at Your home or that of Your directors, principals or Employees
- (vi) in a bank night safe until removed by the bank

- (2) the cost of replacement or repair following loss of or damage to any
 - (a) safe or strongroom specified in The Schedule
 - (b) case, bag or waistcoat used for carrying Moneyfollowing theft or attempted theft of Money
- (3) loss of or damage to clothing and personal belongings owned by You, Your directors, principals or any Employee following theft or attempted theft of Money involving violence or threat of violence

occurring during the Period of Insurance.

The maximum We will pay for any one person is £500.

Exceptions - Part A - Money Only

The Exceptions below apply to Part A - Money of this Section only.

(Also refer to the Policy Exceptions at the back of this policy booklet).

We will not indemnify You in respect of

- (1) loss or shortages due to clerical or accounting errors, or omissions, accountancy depreciation, currency fluctuation or consequential loss of any kind
- (2) loss due to the dishonesty of Your directors, principals or Employees
 - (a) not discovered within seven working days of the loss

- (b) where a more specific insurance is in force, except for any amount in excess of that insurance
- (3) loss of Money from unattended vehicles being any vehicle with no person in charge or keeping the vehicle under observation and able to observe or prevent any attempt by any person to interfere with the vehicle
- (4) loss or damage outside England, Wales and Scotland, Northern Ireland, the Republic of Ireland, the Channel Islands and the Isle of Man
- (5) loss resulting directly or indirectly from
 - (a) forgery
 - (b) fraudulent alteration or substitution
 - (c) fraudulent use of a computer or electronic transfer
- (6) loss resulting from use of any form of payment which proves to be
 - (a) counterfeit
 - (b) false
 - (c) invalid
 - (d) uncollectable
 - (e) irrecoverablefor any reason
- (7) loss of Money from any gaming or vending machine unless specifically stated in The Schedule.

Part B - Assault

Cover

We will pay compensation to You for Bodily Injury to an Insured Person occurring during the Period of Insurance caused by theft or attempted theft, involving violence or threat of violence, which happens in the course of The Business and directly and independently of any other cause results in any of the following Contingencies

- (1) death
 - (2) total and permanent loss of sight in one or both eyes
 - (3) loss of one or more limbs
 - (4) any other total and permanent disablement which, after 24 months of Bodily Injury, prevents the Insured Person from pursuing any occupation
 - (5) total disablement which, within 24 months of Bodily Injury, prevents the Insured Person from pursuing their normal occupation
 - (6) partial disablement which, within 24 months of Bodily Injury, prevents the Insured Person from pursuing a substantial part of their normal occupation.
- } occurring within 24 months of Bodily Injury

Clauses - Part B - Assault Only

The following clauses apply to Part B - Assault of this Section only.

(1) Amounts Payable

- (a) We will pay for any one injury
 - (i) the compensation stated in The Schedule
 - (ii) weekly compensation at four weekly intervals
 - (iii) compensation under contingencies (5) and (6) for a maximum of 24 months from the date that the disablement started
- (b) weekly compensation being paid for the same injury will end if We pay compensation under any of contingencies (1) - (4)
- (c) insurance will end for the Insured Person if We pay compensation under any of contingencies (1) - (4).

(2) Medical Evidence

- (a) We may require, at Our expense,
 - (i) an Insured Person to undergo medical examinations
 - or
 - (ii) a post mortem to be carried out.

(b) You or Your legal representative will supply to Us, at Your expense, any

- (i) certificate
- (ii) information
- (iii) evidence

in the format We require.

Conditions - Part A - Money Only

The following Conditions apply to Part A - Money of this Section only.

(Also refer to the Policy Conditions at the back of this policy booklet).

(1) Records and Key Security

We will not pay any claim unless

- (a) You keep a complete record of Money in a secure place other than in a safe or strongroom containing Money
- (b) outside Business Hours the safe or strongroom will be kept locked and the keys removed from The Premises unless The Premises are occupied by You, Your directors, principals or authorised Employees, in which case the keys will be kept in a secure place away from any safe or strongroom
- (c) whenever The Premises are closed for business or left unattended, all security devices to protect The Premises are properly fitted and put into full operation.

(2) Adjustment of Premium

The premium having been calculated in part on estimates provided by You

- (a) within one month after the expiry of each Period of Insurance You will provide Us with an accurate statement in the form We require so that the premium for that period can be calculated and the difference paid by or allowed to You subject to Our retention of any Minimum Premium We may require

and

- (b) should You fail to supply such a statement within one month after the expiry of each Period of Insurance We will be entitled to charge an additional premium in respect of that Period of Insurance.

Additional Conditions

The following Additional Conditions apply to this Section only if the letter stated against them appears in the Schedule

(Also refer to the Policy Conditions at the back of this policy booklet).

A Intruder Alarm System

For the purpose of this additional condition the following definitions apply

Intruder Alarm System

An electrical installation to detect and indicate the presence, entry or attempted entry of an intruder into Protected Premises.

Protected Premises

The Premises or those portions of The Premises protected by the Intruder Alarm System.

Responsible Person

You or any person authorised by You to be responsible for the security of The Premises.

Keyholder

You or any person or keyholding company authorised by You who must be available at all times to accept notification of faults or alarm signals relating to the Intruder Alarm System, attend, and allow access to The Premises.

If in relation to any claim for loss or damage caused by theft or attempted theft involving entry or exit from The Premises by forcible or violent means, You have failed to fulfil any of the following conditions, You will lose Your right to indemnity or payment for that claim.

While The Premises are unattended You must ensure that

- (1) The Premises are protected by an Intruder Alarm System and means of communication used to transmit signals from such an Intruder Alarm System designed, installed and maintained as agreed by Us.
- (2) the Protected Premises must not be left without at least one Responsible Person in attendance
 - (i) unless the Intruder Alarm System is set in its entirety with all means of communication used to transmit signals in full operation
 - (ii) if the police have withdrawn their response to alarm calls.unless We agree otherwise.
- (3) in the event of notification of any activation of the Intruder Alarm System or interruption of any of the means of communication during any period that the Intruder Alarm System is set, a Keyholder shall attend The Premises as soon as reasonably possible, in order to confirm the security of The Premises and reset the Intruder Alarm System in its entirety. If the Intruder Alarm System cannot be reset in its entirety or all the means of communication used to transmit signals are not in full operation, a Keyholder must remain at The Premises unless We agree otherwise in writing.
- (4) You shall advise Us as soon as possible, and in any event not later than 10.00am on Our next working day,
 - (i) that police attendance in response to alarm signals/calls from the Intruder Alarm System may be withdrawn or the level of response reduced or delayed
 - (ii) of notice from a Local Authority or Magistrate imposing any requirement for abatement of nuisance
 - (iii) that the Intruder Alarm System and the means of communication used to transmit signals from such installation cannot be returned to or maintained in full working order

and You must comply with any of Our subsequent requirements.

- (5) no alteration or substitution of
 - (i) any part of the Intruder Alarm System
 - (ii) the structure of The Premises or changes to the layout of The Premises which would affect the effectiveness of the Intruder Alarm System
 - (iii) the means of communication used to transmit signals from the Intruder Alarm System
 - (iv) the procedures agreed with Us for police or any other response to any activation of the Intruder Alarm System
 - (v) the maintenance contract

shall be made without Our written agreement.

- (6) You and each Keyholder maintain secrecy of codes and security of keys and setting/unsetting devices for the operation of the Intruder Alarm System. All keys and other setting/unsetting devices for the Intruder Alarm System must be removed from The Premises when they are left unattended.
- (7) The Intruder Alarm System is maintained in full and efficient working order under a contract to provide both corrective and preventative maintenance with the installing company or other such company, as agreed by Us.
- (8) You appoint at least two Keyholders and lodge written details (which must be kept up to date) with the alarm company contracted to maintain the Intruder Alarm System, and with the police if they so require.

B Requirements

If in relation to any claim You have failed to implement the requirements set out in The Schedule of Requirements within the timescales specified, You will lose Your right to indemnity or payment for that claim.

C Security Company Exception

We will not indemnify You in respect of loss of Money in the custody of any security company.

D Security Company Contingency Cover

We will indemnify You in respect of loss of Money in the custody of the security company You have an agreement with if You are unable to recover the Money from the security company.

If in relation to any claim in respect of loss of Money in the custody or control of the security company that You have an agreement with, You have failed to fulfil any of the following conditions, You will lose Your right to indemnity or payment for that claim.

You must

- (a) provide Us with a copy of the agreement between You and the security company
- (b) obtain Our written agreement before any changes are made to the agreement
- (c) comply with the terms of the agreement.

E Money in Transit

If in relation to any claim for Money (other than described in Item 1 of the Schedule) in transit You have failed to fulfil any of the following conditions, You will lose Your right to indemnity or payment for that claim.

You must ensure that

- (a) it is accompanied by the following number of persons who must be either You, Your partners, directors or Employees
 - over £2,000 up to £5,000 at least two persons
 - over £5,000 up to £8,000 at least three persons
 - over £8,000 at least four persons
 - over £12,000 as stated in The Schedule
- and
- (b) private transport is used for amounts greater than £2,000 where the distance exceeds half a mile.

Our liability will not exceed the limits stated in The Schedule.

F Visible Evidence

We will not indemnify You in respect of any loss or damage by theft or attempted theft unless there is visible evidence of entry into or exit from any building at The Premises involving forcible and violent means.

G Minimum Security Condition

If in relation to any claim for loss or damage caused by theft or attempted theft involving entry or exit from The Premises by forcible and violent means, occurring more than 30 days after the inception of this Section, You have failed to fulfil any of the following Conditions, You will lose Your right to indemnity or payment for that claim.

You must ensure that

- (1) Final exit doors are secured as follows:
 - (a) timber doors - by mortice deadlocks having five or more levers or conforming to BS3621 with matching boxed striking plate
 - (b) aluminium doors - by cylinder mortice lock operating a swinging lock bolt
 - (c) PVCu doors - by key operated multi-point locking devices having three or more locking points
 - (d) the first closing leaf or double leaf doors must be fitted internally with bolts top and bottom.

When The Premises are closed for business all locks fitted to final exit doors must be put into effect.

- (2) All other external doors and internal doors leading to common areas or other premises, are secured
 - (a) by the means set out in (1), or
 - (b) by key operated security bolts fitted top and bottom

- (3) All opening windows or rooflights accessible from the ground or via roofs, pipework or other structures are secured by key operated locking devices or screwed permanently shut
- (4) Any security measures stipulated or agreed by Us in writing.

Any door or window officially designated a fire exit by the Fire Authority is excluded from these requirements.

Asset Protection Glass

Glass Section

Definitions

(Also refer to the Policy Definitions at the front of this policy booklet).

The following definitions apply to this Section and will keep the same meaning wherever they appear in the Section, unless an alternative definition is stated to apply.

Damage

Accidental loss, destruction or damage.

Excess/Excesses

The amount or amounts shown in Your policy or The Schedule which we will deduct for each and every claim at each separate location.

You will repay any such amount paid by Us.

Cover

We will indemnify You in respect of

(1) Damage (including the cost of boarding up) of glass at The Premises for which You are responsible including

- (a) shelves, showcases and mirrors
- (b) the cost of replacing alarm foil lettering, painting, embossing, silvering, or other ornamental work on glass following Damage

The maximum that We will pay in any one Period of Insurance is £1,000.

- (c) wash hand basins, pedestals, baths, sinks, lavatory bowls, bidets, cisterns, shower trays, splashbacks at The Premises
- (d) the cost of removing and reinstating obstructions to replacing glass

The maximum We will pay for any one replacement is £1,000.

(e) Damage to window and door frames following breakage of glass

The maximum We will pay for any one replacement is £1,000.

(2) Damage to neon and illuminated signs for which You are responsible

We will not indemnify You in respect of

- (a) Damage arising from adjustment, repair, dismantling or erection of any part of the sign or Damage to any part whilst removed from its normal working position
- (b) Damage arising from mechanical breakdown of the sign or any part thereof
- (c) Damage to any part of the sign by its own ignition, electrical breakdown or burn out
- (d) Damage to tubes unless the glass is fractured.

Exceptions

The following exceptions apply to this Section.

(Also refer to the Policy Exceptions at the back of this policy booklet).

We will not indemnify You in respect of

- (1) Damage to glass in
 - (a) light fittings
 - (b) signs
 - (c) Stock and Materials in Trade or goods in trust
 - (d) vehicles
 - (e) vending machines
- (2) Damage to glass caused by
 - (a) scratching
 - (b) gradual deterioration or wear and tear
 - (c) change in colour or finish
- (3) breakage of glass
 - (a) while The Premises are unoccupied or disused
 - (b) in transit or while being fitted
 - (c) by workmen carrying out alterations or repairs to The Premises
- (4) the Excess stated in The Schedule.

Engineering Section

Definitions

(Also refer to the Policy Definitions at the front of this policy booklet).

The following definitions apply to this Section and shall keep the same meaning wherever they appear in the Section, unless an alternative definition is stated to apply.

Breakdown

- (1) The breaking, distortion or burning out of any part of the Plant or Machinery which occurs while the Plant or Machinery is being used normally, arising from any mechanical or electrical defect in the Plant or Machinery
- (2) The complete severance of a rope
- (3) The fracturing or distortion of any part of the Plant or Machinery by frost

including any resultant loss of cooling, lubricating or insulating oil, refrigerant or brine.

Collapse

The sudden and dangerous distortion of any part of the Plant or Machinery caused by crushing stress by force of steam or fluid pressure.

Collapse does not include distortion by pressure or ignition of flue gases.

Damage

Loss, destruction or damage.

Excess/Excesses

The amount or amounts shown in Your policy or The Schedule which We will deduct from for each and every claim.

You will repay any such amount paid by Us.

Explosion

The sudden and violent rending of Plant or Machinery by force of internal steam or fluid pressure.

Explosion does not include

- (a) pressure of chemical action
- (b) ignition of the contents of the Plant or Machinery
- (c) the pressure or ignition of flue gases.

Plant or Machinery

All parts of the Property Insured stated in The Schedule. We will indemnify You against Damage to the firing apparatus, pumps, fans and dedicated controls of any boiler described in The Schedule by the Contingencies set against such boiler.

Plant or Machinery does not include

- (a) non-metallic or refractory linings
- (b)
 - (i) cutting edges or extrusion heads
 - (ii) moulds, patterns or dies
 - (iii) heating elements
 - (iv) cables, ropes, belts or chainsunless these require replacement as a result of Damage for which We have admitted liability
- (c) supporting or enclosing structures, foundations, masonry or brickwork
- (d) any power unit, used only for road or site mobility, where Damage is caused solely by Breakdown
- (e)
 - (i) office equipment
 - (ii) spare partsunless specified in The Schedule
- (f) clothing and personal effects.

Cover

We will indemnify You in respect of Damage occurring during the Period of Insurance to the Plant or Machinery at The Premises by the following Contingencies, if the letter set against it appears on The Schedule.

The maximum We will pay in respect of any one occurrence which gives rise to a claim under this Section is the Limit of Indemnity specified in The Schedule.

Contingencies

A Sudden and Unforeseen Damage

Sudden and unforeseen Damage including

- (1) Breakdown
- (2) Explosion
- (3) Collapse

to Plant or Machinery at The Premises, which requires repair or replacement before normal working of the Plant or Machinery can resume.

B Breakdown, Explosion or Collapse

Breakdown, Explosion or Collapse of Plant or Machinery at The Premises which requires repair or replacement before normal working of the Plant or Machinery can resume.

C Accidental Damage

Accidental Damage to Plant or Machinery at The Premises which requires repair or replacement before normal working of the Plant or Machinery can resume.

Accidental Damage does not indemnify You in respect of Breakdown, Explosion or Collapse.

However, We will indemnify You in respect of any consequent Damage caused by Breakdown, Explosion or Collapse which is not otherwise excluded.

D Liability for hired in Plant or Machinery

- (1) all sums which You are legally liable to pay under any contract of hire for
 - (a) Damage to Plant or Machinery
 - (b) continuing hire charges in respect of Plant or Machinery being repaired or replaced directly due to Damage
- (2) legal costs and expenses which are incurred with Our consent
 - (a) recovered from You by any claimant
 - (b) incurred in defence if a claimprovided that the terms of any hiring agreement are no more onerous than the Model Conditions of the Construction Plant-Hire Association unless agreed by Us.

Section Exception 2 does not apply to this Contingency.

We will not indemnify You in respect of

- (a) Plant or Machinery on hire purchase
- (b) Plant or Machinery on free loan.

Clauses

The following clauses apply to this Section.

Additional Plant or Machinery

We will indemnify You in respect of Damage to additional Plant or Machinery of a similar type to that specified in The Schedule subject to the existing Limit of Indemnity

provided that You

- (1) tell Us of any additional Plant or Machinery before the end of the current Period of Insurance in which it was installed and ready for use
- (2) comply with current law for examination and certification of Plant or Machinery before it is used.

We will not indemnify You if

- (a) Plant or Machinery is unsuitable for its purpose
- (b) You are aware of any material defects in the additional Plant or Machinery.

Adjustment of Premium

Where the premium is based on estimates You have supplied You must keep accurate records (which We may require to examine) of all relevant details and submit a declaration within 30 days of the expiry date of the Period of Insurance.

Basis of Settlement - Reinstatement

In the event of Damage insured by Contingency A, B or C the basis upon which We will calculate the amount We will pay for any claim will be the reinstatement of the Plant or Machinery or other property insured by this Section subject to the following conditions

- (1) if Plant or Machinery or other property insured is destroyed We will pay for its replacement by similar Plant or Machinery or property in a condition as good as but not better or more extensive than its condition when new. If Plant or Machinery or other property is damaged We will pay the cost of repairs but will not pay more than We would have if the Plant or Machinery or other property had been completely destroyed.
- (2) the Plant or Machinery or other property may be replaced on another site in a manner suitable to Your needs but this must not increase Our liability.
- (3) all work must begin and be carried out as quickly as possible.

We will not indemnify You under this clause if

- (a) the parts necessary for repairs are not available at the manufacturers listed prices in which case We will pay for the cost of an equivalent repair to similar property for which parts are available at manufacturers listed prices
- (b)
 - (i) the normal working environment of the Plant or Machinery is a yard, an open sided building, a compound or other open space unless for the purpose of providing effluent, electricity, gas, heating, water or other building services for The Premises
 - (ii) the other property is insured by the Lifted Goods Endorsement or is stock in trade or is in the process of manufacture

in which case the basis of settlement will be indemnity.

Debris Removal

We will indemnify You in respect of costs and expenses incurred with Our consent, for

- (1) removal of debris
- (2) dismantling or demolishing
- (3) shoring or propping

of the Plant or Machinery or other property which has suffered Damage insured under this Section.

We will not indemnify You in respect of costs and expenses

- (a) incurred in removing debris from anywhere other than the site of the Damage and the area immediately adjacent to it
- (b) arising from pollution or contamination of Plant or Machinery or other property not insured by this Section
- (c) more specifically insured.

The maximum We will pay for any or all claims arising out of one cause is £25,000.

European Union and Public Authorities

In the event of Damage We will pay the additional cost of reinstating the Plant or Machinery or other property insured by this Section necessary to comply with any

- (1) European Union Legislation
- (2) Act of Parliament
- (3) Bye-Laws of any public authority.

We will not indemnify You if

- (a) costs incurred
 - (i) in respect of Damage not insured by this Section
 - (ii) where notice was served on You before the Damage occurred
 - (iii) where an existing requirement must be completed within a stipulated period
 - (iv) in respect of Plant or Machinery or other property insured which has not suffered Damage
- (b) any charge or assessment arising from capital appreciation following compliance with any legislation or Bye-Law.

Loss Avoidance Measures

We will indemnify You in respect of reasonable costs and expenses incurred by You to mitigate Damage to the Plant or Machinery which would otherwise be inevitable provided that

- (a) the impending Damage does not stem from any reasonably foreseeable or gradually developing cause and We are satisfied that Damage has been avoided or mitigated as a result of the measures taken

- (b) the Policy terms exceptions clause and conditions shall apply as if Damage had occurred.

The maximum We will pay for any or all claims arising out of one cause is £10,000.

Our Rights

If Damage occurs which may lead to a claim, We may take possession of, or require to be delivered to Us Plant or Machinery which we will deal with in a reasonable manner without incurring liability or reducing Our rights.

We will not pay for Damage if You or anyone acting on Your behalf

- (i) do not comply with Our requirements
- (ii) hinder or obstruct Us

You are not entitled to abandon property to Us.

Prevention of Further Loss

If Damage occurs which may lead to a claim, You shall discontinue the use of any damaged Plant or Machinery unless We authorise otherwise and until such property has been repaired to Our satisfaction.

Temporary Hire of Replacement Plant or Machinery

We will indemnify You in respect of costs and expenses incurred with Our consent for the temporary hire or rental of replacement Plant or Machinery following Damage which is insured under this Section.

We will not indemnify You in respect of any hire or rental costs incurred in the first 48 hours immediately following Damage.

The maximum We will pay for any or all claims arising out of one cause is £10,000.

Supplementary Expenses

We will, at Our discretion, pay additional costs and expenses incurred as a result of

- (1) temporarily repairing Damage to Plant or Machinery
- and
- (2) ensuring the Damage to Plant or Machinery is repaired as soon as possible.

The maximum We will pay for any or all claims arising out of one cause is £10,000.

Temporary Removal and Transit

We will indemnify You in respect of Damage whilst Plant or Machinery is temporarily removed for a period not exceeding 6 months anywhere in the world including transit for the purposes of the Business or for cleaning, renovating or repair.

The maximum We will pay for any or all claims arising out of one cause is £50,000.

Section Exceptions (2) and (12) do not apply to this clause.

Exceptions

The following exceptions apply to this Section.

(Also refer to the Policy Exceptions at the back of this policy booklet).

We will not indemnify You in respect of

- (1) the Excess stated in The Schedule

We will deduct the Excess in respect of any claim or all claims arising out of one cause.

If more than one Excess is stated in The Schedule the highest amount will apply

- (2) Damage caused by or consisting of

- (a) fire, lightning or explosion (except Explosion as defined in this Section)
- (b) aircraft or aerial devices or articles dropped from them
- (c) storm, flood or inundation from the sea
- (d) water leaking or discharged from any sprinkler installation
- (e) subsidence, ground heave or landslip

(f) theft or attempted theft
regardless of any other contributory cause

- (3) the cost of remedying or repairing
- (a) gradual deterioration or wear and tear
 - (b) gradually developing defects, flaws, deformation, distortion, cracks or partial fractures
 - (c) loose parts or defective joints or seams unless caused directly by overheating brought about by shortage of water in Plant or Machinery which is subject to steam or fluid pressure.

However We will indemnify You for any consequent Damage to Plant or Machinery insured under this Section

- (4) (a) the cost of any maintenance work
- (b) Damage caused by the use of any tool or process applied to Plant or Machinery during maintenance, repair, alteration, modification or overhaul
- (5) Damage caused by
- (a) any test or experiment
 - (b) Plant or Machinery being intentionally overloaded
- (6) disappearance or shortage of Plant or Machinery if the loss is discovered during
- (a) the making of an inventory
 - (b) stock taking
- (7) Damage caused by or to materials or substances being treated, handled or processed
- (8) Damage caused by the use of crane(s) unless the lifting operation complies fully with the requirements of BS7121 or any other British or International standard which may replace it
- (9) Damage to or liability arising out of Plant or Machinery which you hire out without Our consent
- (10) any penalty
- (a) for delay or detention

- (b) in connection with guarantees or performance or efficiency
- (c) for liquidated damages or consequential loss
- (d) for liability not specifically provided for by the Section

(11) tyres damaged by

- (a) the application of brakes
- (b) punctures or bursts

(12) Damage to Plant or Machinery during transit by sea or air

(13) Damage to any airborne or waterborne vessel or craft, marine rig or platform or any Plant or Machinery situated on them

(14) Damage caused by Your wilful act or wilful neglect

(15) Damage to experimental or prototype Plant or Machinery

(16) Damage whatsoever resulting directly or indirectly from or in connection with any of the following regardless of any other cause or event contributing concurrently or in any other sequence to the loss

- (a) Terrorism
- (b) civil commotion in Northern Ireland
- (c) any action taken in controlling preventing suppressing or in any way relating to (a) and/or (b) above

Terrorism means:

The maximum We will pay in respect of any one premises is £500,000.

You must provide Us with details of these additional Gross Rentals as soon as possible but at least every six months and pay the appropriate additional premium.

Loss of Investment Income on Late Payment of Gross Rentals

If as a result of Damage We are indemnifying You in respect of Loss of Gross Rentals and the payment by Us to You is made later than the date on which You would normally have expected to receive rent from a lessee, We will pay a further amount representing the investment interest lost to You during the delay period.

Managing Agents Premises

We will indemnify You in respect of Damage to property of Your managing agents at their premises in England, Wales, Scotland, Northern Ireland, the Channel Islands or the Isle of Man.

- (3) caused by industrial action
- (4) other than in England, Wales, Scotland, Northern Ireland, the Channel Islands or the Isle of Man
- (5) lasting less than four hours.

The maximum We will pay under this Additional Clause is £50,000 in respect of any one loss, unless otherwise stated in The Schedule.

We will indemnify You in respect of loss resulting from interruption or interference with The Business as a result of accidental failure of Your supply of gas at the terminal ends of Your suppliers feed to The Premises.

- (2) caused by the exercise of any supply authority's power to withdraw or restrict supply or services
- (3) caused by industrial action
- (4) other than in England, Wales, Scotland, Northern Ireland, the Channel Islands or the Isle of Man
- (5) lasting less than four hours.

The maximum We will pay under this Additional Clause is £50,000 in respect of any one loss, unless otherwise stated in The Schedule.

E Full Failure of Utilities - Water

We will indemnify You in respect of loss resulting from interruption or interference with The Business as a result of accidental failure of Your supply of water at the terminal ends of Your suppliers feed to The Premises.

- (4) caused by drought or other weather conditions unless equipment has been damaged
- (5) other than in England, Wales, Scotland, Northern Ireland, the Channel Islands or the Isle of Man
- (6) lasting less than four hours.

The maximum We will pay under this Additional Contingency is £50,000 in respect of any one loss, unless otherwise stated in The Schedule.

Additional Contingencies N P and Q

occurring within a radius of 5 miles of The Premises.

Harmful Organism

- (a) costs incurred in cleaning, repair, replacement, recall or checking of property,
- (b) in respect of Additional Contingencies N (a) and Q, loss arising from premises other than those directly subject to the occurrence, discovery or accident,
- (c) in respect of Additional Contingency N (b) loss arising from premises other than those directly subject to the occurrence,
- (d) any Business Interruption Extension stated in The Schedule.

Revenue Protection Business Interruption

Clauses

The following Clauses apply to this Section only if stated in The Schedule.

A Deductible

We will deduct the amount of the deductible stated in The Schedule in respect of each and every claim as calculated after the application of all other terms of this Section.

B Provisional Premium Adjustment Clause

Part 1 of this Clause applies only in respect of any insurance which is shown in Your Specification as being on the Sum Insured Basis.

Part 1 (Sum Insured Basis)

The first and annual premiums are provisional. They represent

- (1) 75% of the premiums required at the start of the Period of Insurance

and

- (2) 25%, the balance, to be paid within 6 months of the end of that Period of Insurance.

However, in respect of any Items on

- (a) Gross Profit/Fees/Rentals/Revenue

or

- (b) Net Revenue

the premium paid will be adjusted when We receive a declaration for such Items of the amount earned during the financial year most nearly concurrent with such Period of Insurance as reported by Your professional accountants.

If any Damage has occurred giving rise to a claim for loss under such Items We will increase the declaration for the purpose of premium adjustment by the sum by which the amount earned was reduced during the financial year solely due to the Damage.

If the declaration

- (i) adjusted due to a claim as provided for above

- and
- (ii) proportionately increased where the Maximum Indemnity Period exceeds 12 months

- is less than 75% of the Sum Insured for such Items for the relative Period of Insurance

We will pay to You a pro rata return premium but not more than 33¹/₃% of the provisional premium paid.

- is more than 75% of the Sum Insured for such Items for the relative Period of Insurance

You will pay to Us a pro rata additional premium but not more than 33¹/₃% of the provisional premium paid.

If You fail to provide a declaration within six months of the end of such Period of Insurance You must pay the balance of 25%.

Any other part of this Section dealing with an annual return premium is cancelled.

Part 2 of this Clause applies only in respect of any insurance which is shown in Your Specification as being on the Declaration Linked Basis.

Part 2 (Declaration Linked Basis)

The first and annual premiums are provisional.

They are based on 75% of Estimated Gross Profit/Fees/Rentals/Revenue or Net Revenue.

The premium paid will be adjusted when We receive a declaration for Gross Profit/Fees/Rentals/Revenue or Net Revenue Items.

The declaration must be

- (1) of the amount earned during the financial year most nearly concurrent with the Period of Insurance
- (2) confirmed by Your professional accountant
- (3) provided by You not later than six months after the expiry of each Period of Insurance.

Revenue Protection Business Interruption

If any Damage has occurred giving rise to a claim for loss under such Items We will increase the declaration for the purpose of premium adjustment by the sum by which the amount earned was reduced during the financial year solely due to the Damage.

If the declaration

- (a) adjusted due to a claim as provided for above

and

- (b) proportionately increased where the Maximum Indemnity Period exceeds 12 months
 - (i) is less than 75% of the Estimated Gross Profit/Fees/Rentals/Revenue or Net Revenue for the relative Period of Insurance

We will pay to You a pro rata return premium but not more than 33¹/₃% of the provisional premium paid.

- (ii) is greater than 75% of the Estimated Gross Profit/Fees/Rentals/Revenue or Net Revenue for the relative Period of Insurance

You will pay Us an additional premium, which will be pro rata to the premium paid on 75% of the Estimated Amount.

Any other part of this Section dealing with an annual return premium is cancelled.

C Salvage Sale Clause

If following Damage, giving rise to a claim under this Section, you hold a salvage sale during the Indemnity Period, Paragraph (a) of The Basis of Settlement in respect of Gross Profit is amended so that We will pay in respect of reduction in Turnover the sum produced by applying the Rate of Gross Profit to the amount by which, due to Damage the Standard Turnover exceeds the Turnover during the Indemnity Period (less the Turnover for the period of the salvage sale) from which sum shall be deducted the Gross Profit actually earned during the period of the salvage sale.

D Departmental Clause

If You conduct The Business in departments and independent trading

results are obtainable, the Basis of Settlement of the Gross Profit item will apply separately to each department affected by the Damage.

If the insurance is not on a declaration linked basis, if the Sum Insured by such item is less than the total of all the sums produced by applying the Rate of Gross Profit for each department of The Business (affected by the Damage or not) to its relative Annual Turnover (proportionately increased where the Maximum Indemnity Period exceeds 12 months), You will be Your own insurer for the difference and bear a rateable share of the loss.

E Subrogation Rights Waiver Clause

We agree to waive any rights, remedies or relief to which We may be entitled by subrogation against

- (1) any company whose relationship to You is either a parent to subsidiary or subsidiary to parent as defined in, or within the meaning of the relevant Companies Act or Companies (N.I.) Order, current at the time of Damage.
- (2) any company which is a subsidiary of a parent company of which You are a subsidiary as defined in, or within the meaning of the relevant Companies Act or Companies (N.I.) Order, current at the time of Damage.
- (3) any tenant of Yours provided that
 - (a) the tenant or lessee contributes to the cost of insuring the Property Insured against the event which caused the Damage
 - (b) the Damage did not result from a breach of the terms of the lease by the tenant or lessee
 - (c) the Damage did not result from a criminal, fraudulent or malicious act of the tenant or lessee.

F Payments on Account Clause - Rent

Claim payments on account may be made to You during the Indemnity Period in respect of claims for loss of Gross Rentals on the date which but for the Damage the Gross Rentals would have been due from the lessee.

Revenue Protection Business Interruption

Endorsements

The following Endorsements apply to this Section only if stated in The Schedule.

A Rent Receivable

We will pay in respect of rent receivable the difference between

- (1) the rent which would have been receivable in respect of The Premises during the Indemnity Period but for the Damage
- (2) the amount of rent actually received during the same period

less any savings in charges or expenses of The Business, payable out of rent receivable, which reduce or cease due to the Damage.

If at the time of the Damage the Sum Insured by this item is less than the rent which, but for the Damage would have been receivable during the 12 months from the date of the Damage (proportionately increased where the Maximum Indemnity Period exceeds 12 months), You will

- (a) be Your own insurer for the difference
- (b) bear a rateable share of the loss.

The maximum We will pay is the Sum Insured stated in The Schedule.

B Additional Increased Cost of Working

We will pay in respect of additional cost of working the additional expenditure incurred due to the Damage to maintain The Business during the Indemnity Period which exceeds the amount recoverable in respect of increase in the cost of working, insured by the Item 1 of this Section.

The maximum We will pay is the Sum Insured stated in The Schedule.

C Fines or Damages

We will pay in respect of fines or damages for breach of contract, the sums You are legally liable to pay and will pay in discharge of fines or damages incurred solely due to the Damage, for non-completion or late completion of orders.

The maximum We will pay is the Sum Insured stated in The Schedule.

D Additional Cost of Rent

We will pay in respect of additional cost of rent the amount by which, due to the Damage, the total amount of rent necessarily and reasonably incurred by You during the Indemnity Period No 2 exceeds the rent, which, but for the Damage, You would have incurred in the same period.

The maximum We will pay You is that part of the Sum Insured by this item, which the actual Indemnity Period No 2 bears to the Maximum Indemnity Period relative to this item.

Due to the above, Indemnity Period under the first item of The Schedule will now read Indemnity Period No 1. The definition of Indemnity Period will now relate to Indemnity Period No 1, and the following Definition added.

Definition (for the purpose of this item)

Indemnity Period No 2

The period starting 12 months after the date of the Damage and ending not later than 12 months thereafter during which accommodation alternative to The Premises will be rented due to the Damage.

Any Definition in The Schedule of Maximum Indemnity Period does not apply to this item.

Where a specific expiry date for Indemnity Period No 2 is stated in The Schedule the Sum Insured and annual premium relative to this item shall be proportionately reduced annually to reflect the reducing liability under this item.

The maximum We will pay is the Sum Insured stated in The Schedule.

Revenue Protection Business Interruption

Extensions

The following Extensions only apply to this Section if stated in The Schedule

Damage as insured by Item 1 of this Section is extended to include loss, destruction or damage

- (1) at the undernoted premises or locations
or
- (2) to the undernoted property which results in interruption or interference with The Business

by any Contingency stated in The Schedule as applying to such locations or property.

The maximum We will pay under each extension for any one occurrence will not exceed

- (a) the amount
or
- (b) the percentage of the Sum Insured (or 200% of the Estimated Amount)

stated in The Schedule as the limit.

R Prevention of Access - Loss of Attraction

Property in the vicinity of The Premises which causes a loss of custom to The Business directly due to a reduction in customers visiting the area.

S Loss of Attraction

Buildings or other property at any location in the immediate vicinity of The Premises as a result of which an agreement in course of negotiation to lease the Premises is avoided or delayed and the Gross Rentals or Estimated Gross Rentals received by You are reduced.

U Buildings Awaiting Sale

Buildings, forming part of the Property Insured, that You have contracted to sell or have accepted an offer in writing to purchase the interest in the buildings subject to contract, where that sale is cancelled or delayed solely due to the Damage.

Under this extension We will indemnify You in respect of

- (1) interest payable by You on capital borrowed which, but for the Damage, would be available, from the proceeds of the sale, for investment in The Business
- (2) the additional interest payable by You on amounts borrowed

at a rate of interest not exceeding 2% above the prevailing Inter Bank Lending Rate

- (3) the investment interest lost by You on any proceeds of the sale (after the deduction of any capital borrowed as detailed in (2) above).

We will not indemnify You if You do not make all reasonable efforts to complete the sale as soon as possible following the Damage.

Maximum Indemnity Period

Six months.

Indemnity Period

The period during which the results of The Business are affected due to the Damage, beginning with the date on which, but for the Damage, the building would have been sold and ending with the date of completion or the expiry of the Maximum Indemnity Period if earlier.

W Inadvertent Failure to Insure

Buildings anywhere in England, Wales, Scotland, Northern Ireland, the Channel Islands or the Isle of Man which You have an obligation to insure (whether owned by or leased to You) but which have inadvertently been left uninsured.

The maximum We will pay is £500,000 at any one location in respect of Gross Rentals from any such building.

You must advise Us in writing immediately You become aware of a property inadvertently left uninsured and pay the appropriate premium due from the date the insurance becomes Your responsibility.

Revenue Protection Business Interruption

You must carry out at not less than 12 month intervals a check of all properties owned or leased by You and for which You are responsible to ensure that effective insurance is in force on each of them.

We will not indemnify You in respect of

- (a) any building more specifically insured
- (b) any appreciation in value.

V Failure of Tenants Insurances

Buildings owned by You in England, Wales, Scotland, Northern Ireland, the Channel Islands or the Isle of Man for which (by the terms of an agreement with You) the tenant lessee or other occupier of the building has an obligation to insure but has failed to maintain in force such insurance.

The maximum We will pay at any one Premises is £250,000 for loss of Gross Rentals.

You must advise Us in writing immediately You become aware that such insurance is not in force and pay the appropriate premium for the period such insurance is not effected.

You must obtain written confirmation from the tenant lessee or occupier and their Insurers at the inception of any such agreement that insurance is in force providing at least the extent of cover provided by this policy and also carry out an annual check that insurance is in force for all such properties.

Gross Rentals Sum Insured Basis Specification

Gross Rentals Sum Insured as stated in The Schedule.

Definitions

(Also refer to the definitions stated in this Section and the Policy Definitions at the front of this policy booklet).

The following definitions apply to this Specification and shall keep the same meaning wherever they appear in the Specification.

1 (a) Annual Gross Rentals

Gross Rentals during the 12 months immediately before the date of the Damage

(b) Standard Gross Rentals

Gross Rentals during that period in the 12 months immediately before the date of the Damage which corresponds with the Indemnity Period

Annual Gross Rentals and Standard Gross Rentals may be adjusted to reflect any trends or circumstances which

- (i) affect The Business before or after the Damage
- (ii) would have affected The Business had the Damage not occurred.

The adjusted figures will represent, as near as possible, the results which would have been achieved during the same period had the Damage not occurred.

2 Gross Rentals

Money paid or payable to You by tenants for rental of The Premises and for the services provided in connection with The Business at The Premises.

3 Indemnity Period

The period during which The Business results are affected due to the Damage, beginning with the date of the Damage

and ending not later than the Maximum Indemnity Period.

4 Maximum Indemnity Period

The number of months stated in The Schedule, unless amended in any Additional Contingency.

Notes

- 1 All terms in this Section exclude Value Added Tax to the extent that You are accountable to the Tax Authorities for Value Added Tax.

Basis of Settlement

The insurance on Gross Rentals is limited to loss due to

- (a) loss of Gross Rentals

and

- (b) increase in cost of working.

We will pay

- (i) in respect of loss in Gross Rentals

the amount by which, due to the Damage, the Standard Gross Rentals exceed the Gross Rentals during the Indemnity Period

- (ii) in respect of increase in cost of working

any additional expense You necessarily and reasonably incur solely to prevent or limit a reduction in Gross Rentals during the Indemnity Period which but for such additional expense would have taken place due to the Damage. We will not pay more than the reduction avoided by the expenditure

less any savings during the Indemnity Period in business charges or expenses, payable out of Gross Rentals, which reduce or cease due to the Damage.

If at the time of the Damage the Sum Insured is less than the Annual Gross Rentals (proportionately increased where the Maximum Indemnity Period exceeds 12 months), You will be Your own insurer for the difference and bear a proportionate share of the loss.

Revenue Protection Business Interruption

Clauses

The following Clauses apply to this Specification.

1 Alternative Premises

The Gross Rentals during the Indemnity Period will include Gross Rentals derived elsewhere than from The Premises if The Business is conducted elsewhere than at The Premises.

2 Auditors and Professional Accountants and Legal Fees

We will pay Your auditors, professional accountants and solicitors reasonable charges for

- (a) producing information We require for investigating any claim and
- (b) confirming the information is in accordance with Your business books
- (c) determining Your contractual rights under any rent cessor clause or insurance break clause contained in the lease

but not for any other purposes in the preparation of any claim.

The maximum We will pay for any claim, including auditors and professional accountants and solicitors charges, is the Sum Insured.

3 Automatic Reinstatement

The Sums Insured stated in The Schedule will not be reduced by the amount of any claim unless We or You give written notice to the contrary.

However, You must pay the additional premium required to reinstate the Sum Insured.

4 Return Premium

We will allow a return premium for the Period of Insurance where

- (a) You provide Us with a professional accountants declaration of Gross Rentals earned in Your financial year most closely corresponding to the Period of Insurance

and

- (b) the declared figure (proportionately increased where the Maximum Indemnity Period exceeds 12 months) is less than the Sum Insured.

The adjustment will be based on the difference between the declared figure (proportionately increased where necessary) and the Sum Insured.

The maximum We will repay is 50% of the premium paid by You for the Period of Insurance.

We will not return premium for any reduction in Gross Rentals which is entirely due to a claim.

3 Indemnity Period

The period during which The Business results are affected due to the Damage, beginning with the date of the Damage and ending not later than the Maximum Indemnity Period.

4 Maximum Indemnity Period

The number of months stated in The Schedule, unless amended in any Additional Contingency.

5 Standard Gross Rentals

Revenue Protection Business Interruption

Maximum Amount Payable

The maximum amount We will pay is

 - 200% of the Estimated Gross Rentals stated in The Schedule
 - and
 - 100% of the Sums Insured by other Items unless otherwise agreed by Us.

Clauses

less any savings during the Indemnity Period in business charges or expenses, payable out of Projected Additional Rent, which reduce or cease due to the Damage.

If at the time of the Damage the Sum Insured is less than the Projected Additional Rent which would have been receivable during the Maximum Indemnity Period.

You will be Your own insurer for the difference and bear a rateable share of the loss.

Revenue Protection Business Interruption

Clauses

The following clauses apply to this Specification.

1 Auditors and Professional Accountants

We will pay Your auditors and professional accountants reasonable charges for

- (a) producing information We require for investigating any claim and
- (b) confirming the information is in accordance with Your business books.

The maximum We will pay for any claim, including auditors and professional accountants charges, is the Sum Insured.

Revenue Protection Business Interruption

The period during which The Premises are not available for occupation due to the Damage starting from the date on which, but for Damage, the loan raised on The Project would have been repaid and ending no later than the Maximum Indemnity Period.

Maximum Indemnity Period

The number of months stated in The Schedule, unless amended in any Additional Contingency.

The Project

The construction of the buildings to be used for the purpose of The Business at The Premises.

Loan Interest Charges

Loan Interest Charges You incur during the Indemnity Period on loans, necessarily and reasonably continued due to the Damage which, but for such Damage, would have been repaid at the start of the Indemnity Period.

Basis of Settlement

The insurance on Loan Interest Charges is limited to:

- (1) Loan Interest Charges
- and
- (2) increase in cost of working.

We will pay

- (a) the Loan Interest Charges during the Indemnity Period
- (b) in respect of increase in cost of working

any additional expense You necessarily and reasonably incur solely to prevent or limit the Loan Interest Charges which, but for such expense, would have taken place due to Damage, We will not pay more than the Loan Interest Charges avoided by the expenditure

less

- (i) any sum receivable as interest earned on the proceeds of any other policy of insurance payable due to the Damage
- (ii) any sum receivable as interest earned on monies invested which would not have been available for investment but for the Damage.

If at the time of the Damage the Sum Insured is less than the annual equivalent of Loan Interest Charges (proportionately increased where the Maximum Indemnity Period exceeds 12 months), You will be Your own insurer for the difference and bear a proportionate share of the loss.

- 1 All terms in this Section exclude Value Added Tax to the extent that You are accountable to the Tax Authorities for Value Added Tax.

Basis of Settlement

The insurance on Gross Rentals is limited to loss due to

- (a) loss of Gross Rentals

and

- (b) increase in cost of working.

We will pay

- (i) in respect of loss in Gross Rentals

the amount by which, due to the Damage, the Standard Gross Rentals exceed the Gross Rentals during the Indemnity Period

- (ii) in respect of increase in cost of working

any additional expense You necessarily and reasonably incur solely to prevent or limit a reduction in Gross Rentals during the Indemnity Period which but for such additional expense would have taken place due to the Damage. We will not pay more than the reduction avoided by the expenditure,

Clauses

The following Clauses apply to this Specification.

1 Alternative Premises

The Gross Rentals during the Indemnity Period will include Gross Rentals derived elsewhere than from The Premises if The Business is conducted elsewhere than at The Premises.

2 Auditors, Professional Accountants and Legal Fees

We will pay Your auditors, professional accountants and solicitors reasonable charges for

- (a) producing information We require for investigating any claim and
- (b) confirming the information is in accordance with Your business books
- (c) determining Your contractual rights under any rent cessor clause or insurance break clause contained in the lease

but not for any other purposes in the preparation of any claim.

The maximum We will pay for any claim, including auditors, professional accountants and solicitors charges, is the Sum Insured.

3 Automatic Reinstatement

The Sums Insured stated in The Schedule will not be reduced by the amount of any claim unless We or You give written notice to the contrary.

However, You must pay the additional premium required to reinstate the Sum Insured.

unless otherwise agreed by Us.

Clauses

The following Clauses apply to this Specification.

The Gross Rentals during the Indemnity Period will include Gross Rentals derived elsewhere than from The Premises if The Business is conducted elsewhere than at The Premises.

2 Auditors, Professional Accountants and Legal Fees

We will pay Your auditors, professional accountants and solicitors reasonable charges for

(a) producing information We require for investigating any claim and

(b) confirming the information is in accordance with Your business books.

The maximum We will pay for any claim, including auditors, professional accountants and solicitors charges, is the Sum Insured.

any additional expense You necessarily and reasonably incur solely to prevent or limit a loss of Projected Additional Rent during the Indemnity Period which but for such additional expense would have taken place due to the Damage. We will not pay more than the reduction avoided by the expenditure

less any savings during the Indemnity Period in business charges or expenses, payable out of Projected Additional Rent, which reduce or cease due to the Damage.

or alternatively

The capital outlay on The Premises to the Date of Completion.

In the case of The Premises having been sold prior to the Damage, Tied Capital shall be deemed to be the selling price.

2. Interest on Tied Capital

The interest payable by You on Tied Capital at the rate actually charged to You

or alternatively

notional interest on Tied Capital at 2% above the prevailing Inter Bank Lending Rate.

3. Indemnity Period

The period during which the results of The Business are affected due to the Damage, beginning with the date on which, but for the Damage, The Business would have commenced and ending no later than the Maximum Indemnity Period.

- (b) in respect of increase in cost of working any additional expense You necessarily and reasonably incur solely to prevent or limit the loss of Interest on Tied Capital which, but for such expense, would have taken place due to Damage. We will not pay more than the interest avoided by the expenditure

less

- (i) any sum receivable as interest earned on the proceeds of any other policy of insurance payable due to the Damage
- (ii) any sum receivable as interest earned on monies invested which would not have been available for investment but for the Damage.

If at the time of the Damage the Sum Insured is less than the annual equivalent of Interest on Tied Capital (proportionately increased where the Maximum Indemnity Period exceeds 12 months), You will be Your own insurer for the difference and bear a proportionate share of the loss.

Your estimate of the monies borrowed by You solely due to the Damage, beyond the Date of Completion (proportionately increased where the Maximum Indemnity Period exceeds 12 months) most closely corresponding to the Period of Insurance

or alternatively

the capital outlay on The Premises to the Date of Completion.

In the case of The Premises having been sold prior to the Damage, Tied Capital shall be deemed the selling price.

2 Interest on Tied Capital

The interest payable to You on Tied Capital at the rate actually charged to You

or alternatively

notional interest on Tied Capital at 2% above the prevailing Inter Bank Lending Rate.

3 Indemnity Period

The period during which the results of The Business are affected due to the Damage, beginning with the date on which, but for the Damage, The Business would have commenced and ending no later than the Maximum Indemnity Period.

4 Maximum Indemnity Period

The insurance on Interest on Tied Capital is limited to

- (1) loss of Interest on Tied Capital
- or
- (2) increase in cost of working.

We will pay

- (a) the loss of Interest on Tied Capital during the Indemnity Period
- (b) in respect of increase in cost of working

any additional expense You necessarily and reasonably incur solely to prevent or limit the loss of Interest on Tied Capital which but for such expense would have taken place due to Damage. We will not pay more than the interest avoided by the expenditure

less

- (i) any sum receivable as interest earned on the proceeds of any other policy of insurance payable in consequence of the Damage
- (ii) any sum receivable as interest earned on monies invested which would not have been available for the investment but for the Damage.

Maximum Amount Payable

The maximum amount We will pay in respect of Interest on Tied Capital is 200% of the Estimated Interest on Tied Capital stated in The Schedule.

Clauses

The following clauses apply to this Specification.

1 Auditors, Professional Accountants and Legal Fees

We will pay Your auditors, professional accountants and solicitors reasonable charges for

- (a) producing information We require for investigating any claim and
- (b) confirming the information is in accordance with Your business books
- (c) determining Your contractual rights under any rent cessor clause or insurance break clause contained in the lease

but not for any other purpose in the preparation of any claim.

The maximum We will pay for any claim, including auditors, professional accountants and solicitors charges, is the Sum Insured.

2 Premium Adjustment

You will supply, within six months of the expiry of each Period of Insurance, a professional accountants declaration of Interest on Tied Capital earned in Your financial year most closely corresponding to the Period of Insurance.

We will, for the purposes of premium adjustment, increase the declared figure by the amount by which the Interest on Tied Capital is reduced during the financial year as a result of a claim.

If the declared figure (adjusted as above and proportionately increased where the Maximum Indemnity Period exceeds 12 months) for the relative Period of Insurance

- (a) is less than the Estimated Interest on Tied Capital, We will allow a pro rata return of up to 50% of the premium paid
- (b) exceeds the Estimated Interest on Tied Capital, You will pay a pro rata additional premium.

3 Renewal

You will supply, prior to each renewal, the Estimated Interest on Tied Capital for the financial year most closely corresponding to the following Period of Insurance.

Terrorism Section

Definitions

(Also refer to the Policy Definitions at the front of this policy booklet).

The following definitions apply to this Section and shall keep the same meaning wherever they appear in the Section, unless an alternative definition is stated to apply.

Act of Terrorism

Act of persons acting on behalf of or in connection with any organisation which carries out activities directed towards the overthrowing or influencing by force or violence of Her Majesty's Government in the United Kingdom or any other government de jure or de facto.

Denial of Service Attack

Any actions or instruction constructed or generated with the ability to damage, interfere with or otherwise affect the availability of networks, network services, network connectivity or information systems.

This includes but is not limited to the generation of excess traffic into network addresses, the exploitation of system or network weaknesses and the generation of excess or non genuine traffic between or amongst networks.

Excess/Excesses

The amount or amounts shown in Your policy or The Schedule which We shall deduct from each and every claim at each separate location.

You will repay any such amount paid by Us.

Hacking

Unauthorised access to any computer or other equipment, component, system or item which processes, stores or retrieves data whether Your property or not.

Head/Heads of Cover

Any of the following types of direct insurance cover:

- (1) Buildings and completed structures
- (2) Other property insured under this policy
- (3) Business Interruption
- (4) Book Debts.

Private Individual

Any person other than

- (1) A company, association or partnership
- (2) A trustee or body of trustees where insurance is arranged under the terms of a trust
- (3) A person who owns Residential Property for the purpose of their business as a sole trader
- (4) A person who owns Residential Property of which in excess of 20 per cent of the property is commercially occupied.

Note:

- (a) Where the Residential Property is occupied by a trustee or a sole trader as a private residence and where the property is not a block of flats, each will be deemed to be a Private Individual in respect of that same property

and
- (b) Where two or more persons have arranged insurance on Residential Property in their several names and/or the name of the Policyholder includes the name of a bank or building society or other financial institution for the purpose of noting their interest in the property insured, they will be deemed to be a Private Individual in respect of that property.

Residential Property

- (1) Private dwelling houses and flats
- (2) Household goods and personal effects.

Treasury

The Lords Commissioners of Her Majesty's Treasury from time to time or any successor relevant authority.

Virus or Similar Mechanism

Program, code, programming instruction or any set of instructions intentionally constructed with the ability to damage, interfere with or otherwise adversely affect computer programs, data, files or operations whether involving self-replication or not.

This includes but is not limited to trojan horses, worms and logic bombs.

Cover

We will indemnify You in respect of all losses arising under any of the Heads of Cover resulting from loss or destruction of or damage to property insured under this policy directly caused by an Act of Terrorism occurring during the Period of Insurance at The Premises but only in England, Wales and Scotland but not the territorial seas adjacent thereto as defined by the Territorial Sea Act 1987 nor the Isle of Man or the Channel Islands.

The maximum We will pay under this Section in any one Period of Insurance will not exceed the limit of liability or Sum Insured for each of the Heads of Cover specified in the Section of this policy where the Head of Cover is otherwise insured.

Exceptions

The following exceptions apply to this Section.

- (1) We will not indemnify You in respect of any losses arising under any of the Heads of Cover directly or indirectly caused by or contributed to, by or arising from or occasioned by or resulting from
 - (a) damage to any computer or other equipment, component, system or item which processes, stores, transmits or receives data or any part thereof whether tangible or intangible (including but without limitation any information, programs or software) and whether Your property or not where such damage is caused by Virus or Similar Mechanism, Hacking or Denial of Service Attack.

- (b) riot, civil commotion, war, invasion, act of foreign enemy hostilities (whether war be declared or not), civil war, rebellion, revolution, insurrection or military or usurped power.

- (2) We will not indemnify You in respect of losses arising under any of the Heads of Cover as a result of loss or destruction of or damage to Residential Property insured in the name of a Private Individual.

Conditions

The following conditions apply to this Section.

(Also refer to the Policy Conditions at the back of this policy booklet)

- (1) The insurance provided by this Section is subject to all the Definitions, Conditions and Clauses of the Sections of this policy where the Head of Cover is otherwise insured together with the Policy Definitions and Policy Conditions except
 - (a) any which provide for adjustments of premium
 - (b) any aggregate limit on the amount borne by You as a result of the operation of an Excess
 - (c) any provision for the automatic reinstatement of sums insured
 - (d) any Long Term Undertaking.

and providing that if there is conflict between this Section and the rest of the policy, this Section shall prevail.

- (2) We will not indemnify You under this Section unless and until
 - (a) the Treasury issues a certificate certifying that any loss was caused by an Act of Terrorism as defined in this Section.

or
 - (b) in the event of the Treasury refusing to issue such a certificate a tribunal formed by agreement between Us and Pool Reinsurance Company Limited decides that the cause of such loss was an Act of Terrorism as defined in this Section.

Asset and Revenue Protection Terrorism

- (3) If in relation to any claim You have failed to fulfil any of the following conditions, You will lose your right to indemnity or payment for that claim.
- (a) You must declare to Us all property and/or premises owned by You or for which You are responsible including all such property and/or premises of subsidiary companies unless it is the practice of any subsidiary company to effect its own insurance
 - (b) You must purchase Terrorism insurance from a Pool Reinsurance Company Limited member company in respect of all such property and/or premises.
- (4) We may cancel the cover provided by this Terrorism Section
- (a) by sending You 30 days written notice to Your last known address. We will refund a proportionate part of any premium paid for the unexpired period

or

 - (b) immediately if the premium has not been paid or if there has been a default under an instalment or linked credit agreement. We will not refund any instalment paid.
- (5) In any action or suit or proceedings where we allege that any loss is not covered by this Section the burden of proving that such loss is covered shall be upon You.

Employers' Liability Section

Definitions

(Also refer to the Policy Definitions at the front of this policy booklet).

The following definitions apply to this Section and shall keep the same meaning wherever they appear in the Section, unless an alternative definition is stated to apply.

Bodily Injury

Bodily injury including death, illness, disease or nervous shock.

Compensation

Damages, including interest.

Costs and Expenses

(1) Fees for The Insured's legal representation at

- (a) any Coroner's Inquest or Fatal Accident Inquiry
- (b) proceedings in any Court of Summary Jurisdiction arising out of any alleged breach of statutory duty

(2) Cost and expenses

incurred with Our written consent

(3) Any claimant's legal costs for which The Insured is legally liable

in connection with any event which is or may be the subject of indemnity under this Section.

Terrorism

Any act or acts including but not limited to

- (1) the use or threat of force and/or violence
and/or
- (2) harm or damage to life or to property (or the threat of such harm or damage) including but not limited to harm or damage by nuclear and/or chemical and/or biological and/or radiological means

caused or occasioned by any person(s) or group(s) of persons or so claimed in whole or in part for political, religious, ideological or similar purposes.

The Defined Territories

Great Britain, Northern Ireland, the Isle of Man, the Channel Islands or offshore installations within the Continental Shelf around such territories.

The Insured

- (1) You.
 - (2) Your personal representatives in respect of legal liability You incur.
 - (3) At Your request
 - (a) any director, partner or Employee of Yours
 - (b) the officers, committees and members of Your
 - (i) canteen, social, sports, educational and welfare organisations
 - (ii) first aid, fire, security and ambulance servicesin their respective capacities as such
 - (c) any principal for whom You are carrying out a contract to the extent required by the contract conditions
 - (d) those who hire plant to You to the extent required by the hiring conditions
- or the personal representative of any of these persons

in respect of legal liability for which You would have been entitled to indemnity if the claim had been made against You.

Each indemnified party will be subject to the terms of this Section so far as they apply.

The total amount which We will pay will not exceed The Limit of Indemnity regardless of the number of parties claiming to be indemnified.

Legal Liabilities Employers' Liability

The Limit of Indemnity

The maximum amount, stated in The Schedule, including Costs and Expenses, which We will pay in respect of any one claim or series of claims against The Insured arising out of one cause.

The Territorial Limits

Anywhere in the world in connection with The Business conducted by You from premises within The Defined Territories.

We will not provide indemnity in respect of Bodily Injury to any Employee engaged by You outside The Defined Territories for the purpose of work by any such Employee outside The Defined Territories.

Cover

We will indemnify The Insured against

- (1) legal liability to pay Compensation
and
- (2) Costs and Expenses

in respect of Bodily Injury caused during the Period of Insurance to any Employee arising out of and in the course of employment by You in The Business within The Territorial Limits.

The maximum We will pay is The Limit of Indemnity.

Clauses

The following clauses apply to this Section.

Additional Activities

The Business includes

- (1) ownership, use and upkeep of Your premises.
- (2) upkeep of vehicles and plant owned and used by You.
- (3) canteen, social, sports, educational and welfare organisations for the benefit of any Employee.
- (4) Your first aid, fire, security and ambulance services.

- (5) Your participation in exhibitions.

- (6) private work by any Employee, with Your prior consent, for You or for any director, partner or Employee of Yours.

Contractual Liability

We will indemnify The Insured in respect of liability for Bodily Injury imposed on You solely by reason of the terms of any agreement provided that the conduct and control of any claim is vested in Us.

We will not provide indemnity in respect of any agreement for or including the performance of work outside The Defined Territories.

Cross Liabilities

We will indemnify each party named as The Policyholder in The Schedule as if a separate policy had been issued to each.

The total amount payable will not exceed The Limit of Indemnity regardless of the number of parties claiming to be indemnified.

Legal Expenses arising from Health and Safety Legislation

We will indemnify The Insured in respect of

- (1) legal fees and expenses incurred with Our written consent for defending proceedings, including appeals
- (2) costs of prosecution awarded against The Insured

which arise from any health and safety inquiry or criminal proceedings for any breach of the Health and Safety at Work etc Act 1974 or the Health and Safety at Work (Northern Ireland) Order 1978.

We will not provide indemnity

- (1) unless the proceedings relate to an actual or alleged act, omission or incident committed during The Period of Insurance within The Defined Territories and in connection with The Business.

Legal Liabilities Employers' Liability

- (2) in respect of proceedings which
 - (a) result from any deliberate act or omission by You.
 - (b) relate to the health and safety of any person other than an Employee.
- (3) where indemnity is provided by another insurance policy.

Our Right of Recovery

The indemnity granted by this Section is deemed to be in accordance with the provisions of any law relating to the compulsory insurance of liability to employees in Great Britain, Northern Ireland, the Isle of Man or the Channel Islands.

However, You will repay to Us all sums We would not have been liable to pay but for the provisions of such law.

Payment for Court Attendance

We will compensate You if, at Our request, You, any director, partner or Employee of Yours, is attending court as a witness in connection with a claim for which The Insured is entitled to indemnity.

The maximum We will pay for

- (1) You, each director or partner is £250
per day.
- (2) each Employee is £150
per day.

Unsatisfied Court Judgements

We will, at Your request, pay any Employee or his or her personal representative, the amount of damages and costs awarded to such person as a result of a judgement which has been obtained for Bodily Injury against any company registered in or any individual domiciled in The Defined Territories and which remain unpaid six months after the date of such judgement.

Payment will only be made where

- (1) the Bodily Injury was caused during any Period of Insurance to the Employee arising out of and in the course of employment by You in The Business.

- (2) the judgement was obtained in a court within The Defined Territories.
- (3) there is no appeal outstanding to the judgement.
- (4) the Employee, or his or her personal representative, assigns the judgement debt to Us.

Exceptions

The following exceptions apply to this Section.

We will not provide indemnity in respect of

- (1) work in or on and travel to, from or within any offshore
 - (a) accommodation, exploration, drilling or production rig or platform.
 - (b) support vessel.
- (2) Bodily Injury sustained by any Employee when such person is
 - (a) carried in or upon a vehicle
 - (b) entering or getting on to, or alighting from, a vehiclewhere any road traffic legislation requires insurance or security.
- (3) (a) liquidated damages.
 - (b) penalty clauses.
 - (c) fines.
 - (d) aggravated, restitutionary, punitive or exemplary damages or any additional damages resulting from the multiplication of compensatory damages or other non-compensatory damages.

Legal Liabilities Employers Liability

(4) any consequence whatsoever resulting directly or indirectly from or in connection with any of the following regardless of any other contributory cause or event

(a) Terrorism

(b) any action taken in controlling, preventing, suppressing or in any way relating to (a) above

except as stated in **Special Provision - Terrorism** below

In any action, suit or other proceedings where We allege that any consequence whatsoever resulting directly or indirectly from or in connection with (4)(a) and/or (4)(b) above regardless of any other contributory cause or event is not covered under this Section (or is covered only up to a specified limit of liability) the burden of proving that any such consequence is covered (or is covered beyond that limit of liability) under this Section shall be upon You.

Special Provision - Terrorism

Subject otherwise to the terms of the policy

Neither of the exclusions in (4)(a) and (4)(b) above shall apply to the Employers' Liability Section but the Limit of Indemnity for the purpose of this Special Provision - Terrorism is limited to £5,000,000 including costs and expenses.

Damage

Physical

- (1) loss.
- (2) destruction.
- (3) damage.

Financial Loss

A pecuniary loss suffered by any tenant of The Insured and not caused by Personal Injury of Damage to Property.

Personal Injury

- (1) Bodily Injury.
- (2) Wrongful
 - (a) arrest, detention or imprisonment.
 - (b) eviction.
 - (c) accusation of shoplifting.

Pollution or Contamination

- (1) Pollution or contamination of buildings or other structures or of water or land or the atmosphere
and
- (2) all loss, Damage to Property and Bodily Injury directly or indirectly caused by such pollution or contamination.

Products Supplied

Anything which is

- (1) manufactured, sold, supplied, processed, altered or treated
- (2) repaired, serviced or tested
- (3) installed, constructed, erected or transported

by You or on Your behalf and which is no longer in the custody or control of The Insured.

Property

Material property.

Terrorism

Any act or acts including but not limited to

- (1) the use or threat of force and/or violence
and/or

Legal Liabilities Property Owner's Liability

- (2) harm or damage to life or to property (or the threat of such harm or damage) including but not limited to harm or damage by nuclear and/or chemical and/or biological and/or radiological means

caused or occasioned by any person(s) or group(s) of persons or so claimed in whole or in part for political, religious, ideological or similar purposes.

The Defined Territories

Great Britain, Northern Ireland, the Isle of Man, the Channel Islands or offshore installations within the Continental Shelf around such territories.

The Insured

- (1) You.
- (2) Your personal representatives in respect of legal liability You incur.
- (3) At Your request
- (a) any director, partner or Employee of Yours
 - (b) the officers, committees and members of Your
 - (i) canteen, social, sports, educational and welfare organisations
 - (ii) first aid, fire, security and ambulance services
- in their respective capacities as such
- (c) any principal for whom You are carrying out a contract, to the extent required by the contract conditions
 - (d) those who hire plant to You to the extent required by the hiring conditions

or the personal representatives of any of these persons

in respect of legal liability for which You would have been entitled to indemnity if the claim had been made against You.

Each indemnified party will be subject to the terms of this Section so far as they apply.

The total amount which We will pay will not exceed The Limit of Indemnity regardless of the number of parties claiming to be indemnified.

The Limit of Indemnity

The maximum amount, stated in The Schedule, which We will pay in respect of any one event or all events of a series consequent on or attributable to one original cause.

In respect of

The Limit of Indemnity will apply to the total of all events happening in any one Period of Insurance.

The Territorial Limits

Anywhere in the world in connection with The Business conducted by You from premises within The Defined Territories.

The Works

All works completed or to be completed by You or on Your behalf including

- (1) all materials incorporated or to be incorporated
- (2) plant, tools, equipment and temporary buildings used or to be used

for the period during which You are responsible under contract conditions.

Cover

We will indemnify The Insured against

- (1) legal liability to pay Compensation
- and

- (2) Costs and Expenses

in respect of accidental

- (a) Personal Injury
- (b) Damage to Property
- (c) obstruction, trespass, nuisance or interference with any right of way, air, light or water

which arises in connection with The Business and which happens during the Period of Insurance and within The Territorial Limits.

Legal Liabilities Property Owner's Liability

The maximum We will pay is The Limit of Indemnity and any Costs and Expenses. However, in respect of any claim brought in

- (1) the United States of America or any territory within its jurisdiction
- (2) Canada

the maximum We will pay, inclusive of Costs and Expenses, is The Limit of Indemnity.

Clauses

The following clauses apply to this Section.

Additional Activities

The Business includes

- (1) ownership, use and upkeep of Your premises.
- (2) upkeep of vehicles and plant which are owned and used by You.
- (3) Your canteen, social, sports, educational and welfare organisations for the benefit of any Employee.
- (4) Your first aid, fire, security and ambulance services.
- (5) Your participation in exhibitions.
- (6) private work by any Employee, with Your prior consent, for You or for any director, partner or Employee.

Legal Expenses arising from Consumer Protection Act 1987 and Food Safety Act 1990

We will indemnify The Insured in respect of

- (1) legal fees and expenses incurred with Our written consent for defending proceedings, including appeals
- (2) costs of prosecution awarded against The Insured

which arise from criminal proceedings for any breach of Part II of the Consumer Protection Act 1987 or Part II of the Food Safety Act 1990.

We will not provide indemnity

- (1) unless the proceedings relate to an actual or alleged act, omission or incident committed during the Period of Insurance within The Defined Territories and in

connection with The Business.

- (2) in respect of proceedings which result from any deliberate act or omission by You.
- (3) where indemnity is provided by another insurance policy.

Contractual Liability

We will indemnify The Insured against liability in respect of accidental Bodily Injury or Damage to Property imposed on You solely by reason of the terms of any agreement provided that the conduct and control of any claim is vested in Us.

We will not provide indemnity in respect of any agreement for or including the performance of work outside The Defined Territories.

Cross Liabilities

We will indemnify each party named as The Policyholder in The Schedule as if a separate policy had been issued to each.

The total amount payable will not exceed The Limit of Indemnity regardless of the number of parties claiming to be indemnified.

We will indemnify The Insured in respect of

arising from proceedings brought against The Insured under Section 13 of the Data Protection Act 1998.

The maximum We will pay for all claims happening during any one Period of Insurance is £1,000,000.

Defective Premises

We will indemnify The Insured in respect of legal liability for accidental Bodily Injury or Damage to Property arising under

- (1) the Defective Premises Act 1972

- (2) the Defective Premises (Northern Ireland) Order 1975 or the Defective Premises (Landlord's Liability) Act (Northern Ireland) 2001

in connection with any premises which You previously owned or occupied for the purposes of The Business.

We will not provide indemnity in respect of the cost of rectifying any defect or alleged defect in such premises.

Employees' and Visitors' Personal Belongings

We will indemnify the Insured in respect of legal liability for accidental Damage to employees' and visitors' vehicles and personal belongings which are in the custody or control of The Insured.

We will not provide indemnity where this Property is

- (1) loaned, leased, hired or rented to The Insured.
- (2) stored for a fee or other consideration by The Insured.
- (3) in the custody or control of The Insured for the purposes of being worked upon.

Financial Loss - Property Owners

We will indemnify The Insured in respect of legal liability for Financial Loss as a direct result of the failure to provide any Property or service in connection with Property Insured as detailed under the Property Damage Section of this policy

The maximum We will pay, including Costs and Expenses, in respect of all claims made against The Insured in any one Period of Insurance is £500,000

This indemnity only applies to claims made against The Insured during the currency of this Clause or within 30 days of its expiry.

We will not provide indemnity

 - (a) circumstances which, at inception of this Property Owner's Liability Section, The Insured knew or ought to have known about and which were likely to give rise to a claim.

Legal Liabilities Property Owner's Liability

- (b) fraud, dishonesty, insolvency, financial default, conspiracy, conversion, deceit, intimidation, inducement of breach of contract or injurious falsehood.
- (c) passing off or infringement of any trademark, trade name, merchandise mark, registered design, copyright or patent right.

We will indemnify The Insured in respect of

- (1) legal fees and expenses incurred with Our written consent for defending proceedings, including appeals
- (2) costs of prosecution awarded against The Insured

which arise from any health and safety inquiry or criminal proceedings for any breach of the Health and Safety at Work etc Act 1974 or the Health and Safety at Work (Northern Ireland) Order 1978.

We will not provide indemnity

- (1) unless the proceedings relate to an actual or alleged act, omission or incident committed during the Period of Insurance within The Defined Territories and in connection with The Business.

- (2) in respect of proceedings which
 - (a) result from any deliberate act or omission by You.
 - (b) relate to the health and safety of any Employee.
- (3) where indemnity is provided by another insurance policy.

Motor Contingent Liability

We will indemnify You in respect of Your legal liability for accidental Bodily Injury and Damage to Property which arises from any vehicle or trailer attached thereto which is

- (1) (a) not owned by
- (b) loaned, leased, hired or rented to You nor provided by You
- and
- (2) being used in connection with The Business in The Defined Territories.

We will not provide indemnity

- (1) in respect of Damage to the vehicle or trailer or goods carried in or on the vehicle or trailer.
- (2) while the vehicle is being driven by
 - (a) You.
 - (b) any person who to Your knowledge or that of Your representatives does not hold a licence to drive the vehicle unless such person has held and is not disqualified from holding or obtaining such a licence.
- (3) where indemnity is provided by another insurance policy.

Overseas Personal Liability

We will indemnify You and, at Your request, any director, partner or Employee of Yours in respect of legal liability for accidental Bodily Injury or Damage to Property incurred in a personal capacity whilst such persons are temporarily outside The Defined Territories in connection with The Business.

We will also indemnify any accompanying spouse and children.

Legal Liabilities Property Owner's Liability

Where You are an individual, this indemnity will also apply to Your personal liability whilst away from Your business premises in connection with The Business but within The Defined Territories.

We will not provide indemnity

- (2) all flammable and combustible materials are removed
- (3) all external doors and windows are closed and securely locked and other similar precautions taken to prevent unauthorised access
- (4) arrangements are in force to check the unoccupied building internally and externally at least every seven days for evidence of unauthorised access

Additional Endorsements

A Indemnity to Managing Agents

in respect of any building owned but not occupied by You.

Property Owner's Legal Protection

The following notes are designed to assist You in understanding Your Legal Protection cover and the process that You must follow to ensure that You obtain the maximum benefit from this cover.

The claims service for this Section of the policy is administered by DAS Legal Expenses Insurance Company Limited on Our behalf. DAS pioneered the legal expenses market in this country during the mid-seventies and are today recognised as the UK's leading legal expenses insurer. We have chosen DAS as Our Claims Administrator for this cover in view of their expertise and many years experience in dealing with legal disputes for customers.

To ensure that You get the maximum benefit from this Section of the policy You should follow the guidelines below:

- As soon as You are aware of an incident, You should get legal advice from the legal helpline on 01738 630005 without delay. Please have Your policy number to hand.
- If You think that You might need to claim contact DAS Legal Expenses Insurance Company Limited on 0117 934 2000 and request a claim form. DAS will only proceed with Your claim once they have received details of the incident in writing. A claim form is available to download at www.norwich-union.com/legalprotection. DAS will administer the claim on behalf of Norwich Union.
- If a solicitor is required to deal with Your legal problem DAS will appoint one from their approved panel of solicitors. These solicitors have been carefully chosen as experts in the area of law covered by the policy and they are required to comply with strict service standards set by DAS.

Please note that all civil claims covered by this Section of the policy are subject to the provision of 'Prospects of Success', this is stated in item (3) under the Cover heading in this Section. This means that You must have a greater chance of winning a case than not, make a successful defence or obtain another legal remedy agreed by DAS. This will be assessed by DAS or a suitably qualified person who has been appointed by them.

If a case is deemed not to have 'prospects' the cover provided by this Section will not operate. You will be informed in writing of the reason why.

Definitions

Appointed Representative

The lawyer, accountant or other suitably qualified person, who has been appointed to act for an Insured Person in accordance with the terms of this Section.

Aspect Enquiry

An examination by the Inland Revenue which considers one or more specific aspects of Your self-assessment and/or corporation tax return.

Costs and Expenses

(1) Legal costs

- (a) All reasonable and necessary costs chargeable by the Appointed Representative on a standard basis.
- (b) Costs incurred by opponents in civil cases if an Insured Person has been ordered to pay them, or pays them with the agreement of The Claims Administrator.

(2) Accountants Costs

All reasonable and necessary accountancy costs incurred by the Appointed Representative.

(3) Attendance Expenses

- (a) The salary or wages of the Insured Person for the time they are off work

Legal Liabilities Property Owner's Legal Protection

(b) We will pay for each half or whole day that the

- (i) court
- (ii) tribunal
- (iii) employer of the Insured Person

will not pay for.

(c) The amount We will pay is based on the following

- (i) the time the Insured Person is off work including the time it takes to travel to and from the hearing. This will be calculated to the nearest half day assuming that a whole day is eight hours.
- (ii) if the Insured Person
 - works full time, the salary or wages for each whole day equals 1/250th of the annual salary or wages of the Insured Person.
 - works part-time, the salary or wages will be a proportion of the weekly salary or wages of the Insured Person.

Date of Occurrence

- (1) civil cases - when the cause of action accrued (other than Contingencies 4A, 4B or 4C).

Hotel Expenses

Hotel Expenses to cover the cost of accommodation up to an amount not exceeding £75 per day for a maximum of 30 days.

Insured Person

- (1) You
- (2) any director of Yours, or partner, or proprietor of The Business
- (3) any employee of Yours under a contract of employment with You.

Limit of Indemnity

The maximum amount stated in the Schedule which We will pay for Costs and Expenses in respect of any or all claims arising out of one cause in connection with the business as stated in The Schedule.

Territorial Limits

For Contingencies 2 Legal Defence (other than Contingency 2(4)) and 6 Bodily Injury

The European Union, the Isle of Man, the Channel Islands, Albania, Andorra, Bosnia Herzegovina, Bulgaria, Croatia, the Czech Republic, Gibraltar, Hungary, Iceland, Liechtenstein, Macedonia, Malta, Monaco, Montenegro, Norway, Poland, Romania, San Marino, Serbia, Slovakia, Slovenia, Switzerland and Turkey (West of the Bosphorus).

For all other Contingencies

Great Britain, Northern Ireland, the Isle of Man or the Channel Islands.

The Claims Administrator

DAS Legal Expenses Insurance Company Limited who administer the claims service for this insurance on Our behalf.

Legal Liabilities Property Owner's Legal Protection

Cover

We will indemnify the Insured Person in the terms of the Contingencies stated in The Schedule as applying. If an Appointed Representative is used, We will pay the Costs and Expenses incurred for this

provided that

- (1) the Contingency occurs within the Territorial Limits and the Date of Occurrence is within the Period of Insurance
- (2) any legal proceedings will be dealt with by a court or other body which The Claims Administrator agree to, within the Territorial Limits
- (3) in civil claims it is always more likely than not that the Insured Person will recover damages (or obtain any other legal remedy which The Claims Administrator have agreed to) or make a successful defence.
- (4) For all Contingencies The Claims Administrator will help in appealing or defending an appeal provided that the Insured Person tells The Claims Administrator within the time limits allowed that they want The Claims Administrator to appeal. - (3) mining subsidence
- (4) a motor vehicle
 - (a) owned, hired or leased by an Insured Person other than damage to motor vehicles where You are engaged in the business of selling motor vehicles

 - (b) used by an Insured Person.

Contingency Conditions

- (1) You must prepare prior to the grant of the tenancy, a detailed inventory allowing space for comments to be made as a condition of the items in the inventory on check in and comments to be made later on check out of the premises.

 - ground 7 - Death of Tenant
 - ground 8 - Statutory minimum rent arrears

of the Housing Act 1988 as amended by the Housing Act 1996

- (ii) Schedule 5 Part 1

- ground 1 - Landlords former or intended occupation
- ground 2 - Landlord default of a heritable security
- ground 3 - Out of season holiday letting

- ground 4 - Out of term letting by an educational institution
- ground 5 - Property required for a minister of religion
- ground 6 - Demolition or substantial works to premises
- ground 7 - Death of Tenant
- ground 8 - Statutory minimum rent arrears

of the Housing (Scotland) Act 1988

You must give the tenant the correct notices telling him or her that You want possession of The Premises.

- (2) Your legal rights in trying to get possession of The Premises that You've let within Northern Ireland, the Isle of Man or the Channel Islands.
- (3) Your legal rights in trying to get possession of The Premises if You have let The Premises to a limited company or partnership and The Premises has been let for people to live in.
- (4) Your legal rights in trying to get possession of The Premises if You have let The Premises and You live in The Premises as the landlord
- (5) Your legal rights to evict anyone in The Premises who has not got Your permission to be there.
- (6) Your legal rights to recover any rent Your tenant owes You for The Premises
- (7) We will pay hotel expenses while You try to get a possession order for The Premises so You can live in it.

We will not indemnify You in respect of

- (1) any dispute with Your tenant where the cause of action arises within the first 90 days of the start of this cover and the tenancy agreement commenced prior to the start of this cover
- (2) any dispute with any person other than Your tenant or someone in The Premises without Your permission to be there if The Premises is part of a building which contains five or more apartments or flats

Conditions to Contingency 1C

If in relation to any claim You have failed to fulfil any of the following conditions You will lose Your right to indemnity or payment for that claim.

You shall

- (1) not allow an adult tenant into possession other than on the basis of an already completed written tenancy agreement duly signed by all parties.
- (2) ensure that all relevant and necessary statutory pre-grant notices are served in the correct form on the tenant prior to the grant of the tenancy.
- (3) prior to the grant of any tenancy make all relevant and necessary searches to reveal county court judgements in the last five years against the proposed tenant by name.
- (4) not allow a tenant into possession with an unsatisfied County Court Judgement or a Sheriff Court Decree or if they are an undischarged bankrupt.
- (5) not let The Premises as student accommodation.
- (6) prior to the grant of any tenancy obtain a minimum of three satisfactory references including one from the tenant's employer (unless retired), a financial reference (e.g. a bank) and one other referee. If any doubts as to the integrity or financial standing of the tenant are expressed in any reference or there is a lack of response to any enquiry, You should not proceed with letting. On the making of any claim You should be in a position to forward not only copies of the notices to The Claims Administrator but also copies of the letters requesting the same. You should not allow the tenant into occupation until the first months rent and the dilapidations deposit payment have been cleared in Your or the managing agents bank account (or alternatively cash has been received).
- (7) ensure that all statutory requirements are complied with regarding the issue and service of notices of intention to take proceedings.
- (8) ensure that all statutory and/or pre-proceeding notices are served personally with the person serving the notice if possible retaining a copy of the notice duly signed and dated by way of receipt by the recipient(s) of the notice.
- (9) keep clear, up-to-date rental records.

 - (b) the premises which are subject to the dispute are insured by the Policy to which this insurance attaches.

We will not provide indemnity in respect of

- (1) any claim where the cause of action arises within 90 days of the start of this cover.

- (2) the recovery of money and interest due from a tenant other than disputes where the tenant intimates that a defence exists.
- (3) a dispute arising from or relating to
 - (a) the renewal of the lease or tenancy agreement.
 - (b) a rent review.
 - (c) the supply of service by or through You.

Contingency 2 - Legal Defence

At Your request The Claims Administrator will

- (1) defend the legal rights of an Insured Person
 - (a) prior to the issue of legal proceedings when dealing with the
 - (i) Police
 - (ii) Health and Safety Executive and/or Local Authority Health and Safety Enforcement Officerwhere it is alleged the Insured Person has or may have committed a criminal offence
 - (b) following an event which leads to the Insured Person being prosecuted in a court of criminal jurisdiction
 - (c) following civil action taken against the Insured Person for compensation under Section 13 of the Data Protection Act 1998. (We will also pay any compensation award made against the Insured Person under Section 13 of the Data Protection Act 1998)
- (2) defend Your legal rights following civil action taken against You for wrongful arrest in respect of an accusation of theft alleged to have been carried out during the Period of Insurance
- (3) defend the legal rights of an Insured Person (other than You) if
 - (a) an event arising from their work as an Insured Person leads to civil action being taken against them under legislation for unlawful discrimination on the grounds of

Legal Liabilities Property Owner's Legal Protection

- (i) sex
- (ii) sexual orientation
- (iii) race
- (iv) disability
- (v) age
- (vi) religious belief
- (vii) political opinion.

(b) civil action being taken against them as a trustee of a pension fund set up for the benefit of Your employees.

- (4) represent the Insured Person in appealing against the imposition or terms of Statutory Notice issued under legislation affecting Your Business.
- (5) represent You in appealing against the refusal of the Information Commissioner to register Your application for registration
- (6) pay the Attendance Expenses of an Insured Person for jury service provided that
 - (a) in respect of proceedings under the Health and Safety at Work etc. Act 1974, the Territorial Limits shall be any place where the Act applies
 - (b) at the time of the insured incident, You are registered with the Information Commissioner in respect of Contingency 2 (1)(c).

- (1) the amount in dispute exceeds £250
- (2) if the amount in dispute exceeds £5,000, You will be responsible for the first £500 of legal costs in respect of each and every claim
- (3) if the amount in dispute is payable by instalments, the instalments due and payable at the time of making the claim exceed £250
- (4) the dispute relates to money owed to You, a claim must be made within 90 days of the money becoming due and payable.

We will not provide indemnity in respect of

 - (d) a motor vehicle owned by, hired or leased to You other than agreements relating to the sale of motor vehicles where You are engaged in the business of selling motor vehicles.
- (2) A dispute with an Insured Person or former Insured Person which arises out of or relates to a contract of employment with You.
- (3) a dispute which arises from the
 - (a) sale
 - (b) provision
 - (c) purchase
 - (d) hireof computer hardware, software, systems or services which have been specifically tailored.
- (4) a dispute arising from the breach or alleged breach of professional duty by an Insured Person.

Legal Liabilities Property Owner's Legal Protection

- (5) the recovery of money and interest due from another party other than disputes where the other party intimates that a defence exists.

Contingency 3B - Debt Recovery

The Claims Administrator will negotiate for Your legal rights including enforcement of judgement to recover money and interest due from the sale or provision of goods or services provided that

- (1) the amount in dispute exceeds £250
- (2) You have exhausted all reasonable credit control and accounting procedures
- (3) The Claims Administrator has the right to select the method of enforcement or to forego enforcing judgement if The Claims Administrator is not satisfied that there are, or will be, sufficient assets available to satisfy judgement
- (4) You supply the correct and current name and address of the debtor
- (5) a claim for debt recovery under this Contingency is made within 90 days of the money becoming due and payable.

We will not provide indemnity in respect of

- (1) any claim relating to
 - (a) the settlement payable under an insurance policy
 - (b) a lease, licence or tenancy of land or buildings
 - (c) a loan, mortgage, pensions or any other financial product and choses in action
 - (d) a motor vehicle owned by, hire or leased to You other than agreements relating to the sale of motor vehicles where You are engaged in the business of selling motor vehicles.
- (2) a dispute with an Insured Person or former Insured Person which arises out of, or relates to, a contract of employment with You.

- (3) a dispute which arises from the

- (a) sale
- (b) provision
- (c) purchase
- (d) hire

of computer hardware, software, systems or services which have been specifically tailored.

- (4) the recovery of money and interest due from another party where the other party intimates that a defence exists.

Contingency 4A - Full or Aspect Enquiries

The Claims Administrator will negotiate on Your behalf and represent You in any appeal proceedings in respect of a Full Enquiry and/or Aspect Enquiry carried out by the Inland Revenue.

The maximum amount We will pay for Aspect Enquiries in respect of any one claim is the limit stated in the Schedule.

Contingency 4B - Employers Compliance

The Claims Administrator will negotiate on Your behalf and represent You in any appeal proceedings in respect of a dispute concerning Your compliance with

- (1) Pay as You Earn
- or
- (2) Social Security Regulations

following a review by the Inland Revenue or the Department of Social Security Contributions Agency.

Contingency 4C - VAT Disputes

- (5) for the first £200 of Costs and Expenses for Aspect Enquiries in respect of any one claim.

The Claims Administrator will represent You in defending Your legal rights

- (1) prior to the issue of legal proceedings in a court or tribunal following the dismissal of an Insured Person
- (2) in the resolution of unfair dismissal disputes under the ACAS Arbitration Scheme
- (3) in legal proceedings in respect of any dispute with
 - (a) an Insured Person
 - (b) a former Insured Person
 - (c) a trade union acting on behalf of an Insured Person or a former Insured Person

which arises out of, or relates to, a contract of employment with You

- (4) in legal proceedings in respect of any dispute with
 - (a) an Insured Person
 - (b) a former Insured Person
 - (c) a prospective Insured Personarising from an alleged breach of their statutory rights under employment legislation.

We will not provide indemnity for any claim in respect of damages for personal injury or loss of or physical damage to material property.

Contingency 5A - Employment Disputes

The Claims Administrator will represent You in defending Your legal rights

- (1) prior to the issue of legal proceedings in a court or tribunal following the dismissal of an Insured Person
- (2) in the resolution of unfair dismissal disputes under the ACAS Arbitration Scheme
- (3) in legal proceedings in respect of any dispute with
 - (a) an Insured Person
 - (b) a former Insured Person
 - (c) a trade union acting on behalf of an Insured Person or a former Insured Person

which arises out of, or relates to, a contract of employment with You

- (4) in legal proceedings in respect of any dispute with
 - (a) an Insured Person
 - (b) a former Insured Person
 - (c) a prospective Insured Person

arising from an alleged breach of their statutory rights under employment legislation.

We will not provide indemnity for any claim in respect of damages for personal injury or loss of or physical damage to material property.

Contingency 5B - Compensation Awards

We will indemnify You in respect of

- (1) any basic and compensatory award
- (2) an order for compensation following a breach of Your statutory duties under employment legislation

in respect of a claim The Claims Administrator have accepted under Contingency 5A.

The maximum amount We will pay in respect of compensation awards in any one Period of Insurance is the limit stated in the Schedule.

We will not provide indemnity in respect of

- (1) non payment of money due under the relevant contract of employment or related statutory provision.
- (2) any compensation award related to
 - (a) trade union activities, trade union membership or non-membership
 - (b) pregnancy or maternity rights
 - (c) health & safety related dismissals brought under section 44 of the Employment Rights Act 1996
 - (d) statutory rights in relation to trustees of occupational pension schemes
 - (e) statutory rights in relation to Sunday shop and betting work.
- (3) any award ordered as a result of a breach of statutory rights in relation to the provision of relevant records to employees under the National Minimum Wage Act 1998.

Conditions to Contingency 5B

If in relation to any claim You have failed to fulfil any of the following conditions You will lose Your right to indemnity or payment for that claim.

- (3) Redundancy

In respect of any compensation award for

- (a) redundancy
- (b) alleged redundancy
- (c) unfair selection for redundancy

You have sought and followed the advice of The Claims Administrator prior to serving notice of dismissal (01738 630005).

- (4) Compensation Awards

In respect of compensation awards,

- (a) is awarded by a tribunal or through the ACAS Arbitration Scheme, under a judgement made after full argument.
- (b) is approved by The Claims Administrator in writing.

Contingency 5C - Service Occupancy

The Claims Administrator will negotiate for Your legal rights against an Insured Person or former Insured Person to recover possession of premises owned by You, or for which You are responsible.

We will not indemnify You in respect of any claim relating to defending Your legal rights other than defending a counter claim.

Contingency 6 - Bodily Injury

At Your request, The Claims Administrator will negotiate for the legal rights of an Insured Person and their family members following an event which causes the death of, or bodily injury, to them.

We will not provide indemnity in respect of any claim relating to

- (1) any illness or bodily injury which develops gradually or is not caused by a specific or sudden accident.
- (2) defending the legal rights of an Insured Person or their family members other than defending a counter claim.
- (3) a motor vehicle owned, hired, leased or used by an Insured Person or their family members.

Contingency 7 - Statutory Licence Protection

The Claims Administrator will represent You in appealing to the relevant statutory or regulatory authority, court, or tribunal following an event which results in the relevant licensing or regulatory authority suspending, or altering the terms of, or refusing to renew, or cancelling Your licence or British Standard Certificate of Registration.

We will not provide indemnity in respect of

- (1) an original application or application for renewal of a statutory licence or British Standard Certificate of Registration.
- (2) any licence appeal relating to the ownership, driving or use of a motor vehicle.

Exceptions

The following exceptions apply to this Section.

(Also refer to the Policy Exceptions at the back of this policy booklet).

- (1)
 - (a) any claim reported to Us more than 180 days after the date the Insured Person should have known about the claim.
 - (b) any claim relating to subsidence mining or quarrying.
 - (c) any Costs and Expenses incurred before the written acceptance by The Claims Administrator of a claim.
 - (d) fines, penalties, compensation or damages which the Insured Person is ordered to pay by a court or other authority other than compensation awards covered under Contingency 5B (Compensation Awards) and Contingency 2 (Legal Defence).
 - (e) any claim relating to
 - (i) patents
 - (ii) copyrights
 - (iii) trademarks
 - (iv) merchandise marks
 - (v) registered designs
 - (vi) intellectual property
 - (vii) secrecy and confidentiality agreements.
 - (f) any claim relating to franchise or agency rights where You have the legal capacity to alter the legal relations of another.
 - (g) any claim deliberately or intentionally caused by the Insured Person.
 - (h) a dispute with The Claims Administrator not catered for in Section Condition 7.
 - (i) any claim relating to a shareholding or partnership share in the Business unless such shareholding was acquired under a scheme open to all Your employees or to a substantial number of them of a certain minimum grade other than Your directors or partners.

Legal Liabilities Property Owner's Legal Protection

- (j) an application for judicial review.
 - (k) any legal action an Insured Person takes which The Claims Administrator or the Appointed Representative have not agreed to

and/or

where the Insured Person does anything that hinders The Claims Administrator or the Appointed Representative.
 - (l) any claim relating to any non-contracting party's rights to enforce all or any part of this policy. The Contracts (Rights of Third Parties) Act 1999 does not apply to this Section.
- (2) a claim notified under this policy when, either at the start of or during the course of the claim You
- (a) are bankrupt
 - (b) have filed a bankruptcy petition or winding-up petition
 - (c) have made an arrangement with creditors
 - (d) have entered into a deed or arrangement
 - (e) are in liquidation
 - (f) are or part of or all of Your affairs or property are in the care or control of a receiver or administrator.

Conditions

The following conditions apply to this Section.

(Also refer to the Policy Conditions at the back of this policy booklet).

- (1) An Insured Person must
- (a) keep to the terms and conditions of this Section
 - (b) notify Us immediately of any alteration which may materially affect Our assessment of the risk
 - (c) take reasonable steps to keep any amount We have to pay as low as possible

- (d) try to prevent anything happening that may cause a claim
- (e) send everything The Claims Administrator ask for, in writing
- (f) give The Claims Administrator full details of any claim as soon as possible and give The Claims Administrator any information they need.

- (2) (a) The Claims Administrator can take over and conduct in the name of an Insured Person, any claim or legal proceedings at any time. The Claims Administrator can negotiate any claim on behalf of an Insured Person
- (b) An Insured Person is free to choose an Appointed Representative (by sending the Claims Administrator a suitably qualified person's name and address) if:
- (i) the Claims Administrator agrees to start court proceedings and it becomes necessary for a lawyer to represent the interests of an Insured in those proceedings; or
 - (ii) there is a conflict of interest

The Claims Administrator may choose not to accept an Insured Person's choice, but only in exceptional circumstances. If there is a disagreement over the choice of Appointed Representative in these circumstances, the Insured Person may choose another suitably qualified person

- (c) In all circumstances except those in (2)(b) above, the Claims Administrator is free to choose an Appointed Representative
- (d) an Appointed Representative will be appointed by The Claims Administrator and represent an Insured Person according to their standard terms of appointment. The Appointed Representative must co-operate fully with The Claims Administrator at all times
- (e) The Claims Administrator will have direct contact with the Appointed Representative

Legal Liabilities Property Owner's Legal Protection

- (f) an Insured Person must co-operate fully with The Claims Administrator and the Appointed Representative and must keep The Claims Administrator up-to-date with the progress of the claim
- (g) an Insured Person must give the Appointed Representative any instructions that The Claims Administrator require.
- (3) (a) an Insured Person must tell The Claims Administrator if anyone offers to settle a claim
- (b) if an Insured Person does not accept a reasonable offer to settle a claim, We may refuse to pay further Costs and Expenses
- (c) The Claims Administrator may decide to pay the Insured Person the amount of damages that the Insured Person is claiming or is being claimed against them instead of starting or continuing legal proceedings.
- (4) (a) if The Claims Administrator asks, an Insured Person must tell the Appointed Representative to have Costs and Expenses taxed, assessed or audited
- (b) an Insured Person must take every step to recover Costs and Expenses that We have to pay and must pay Us any Costs and Expenses that are recovered.
- (5) If an Appointed Representative refuses to continue acting for an Insured Person or if an Insured Person dismisses an Appointed Representative, the cover We provide will end at once, unless The Claims Administrator agree to appoint another Appointed Representative.
- (6) If an Insured Person
- (a) settles a claim
- (b) withdraws their claim without the agreement of The Claims Administrator
- (c) does not give suitable instructions to an Appointed Representative
- the cover We provide will end immediately and We will be entitled to re-claim any Costs and Expenses paid by Us.
- (7) If The Claims Administrator and an Insured Person disagree about
- (a) the choice of Appointed Representative and/or
- (b) about the handling of a claim
- The Claims Administrator and the Insured Person can choose another suitably qualified person, to decide the matter. The Claims Administrator and the Insured Person must both agree to this in writing. If the Claims Administrator cannot agree with the Insured Person about the choice of the second suitably qualified person, The Claims Administrator will ask the president of a relevant national law society to choose a suitably qualified person. Whoever loses the disagreement will have to pay the costs of settling it.
- (8) The Claims Administrator may at their discretion require You to obtain an opinion from counsel at Your expense as to the merits of a claim or proceedings. If counsel's opinion indicates that there are reasonable grounds for the pursuit or defence of a claim or proceedings, the cost of obtaining the opinion will be paid by Us.
- (9) All references to Acts of parliament within this Section wording shall include equivalent legislation in Scotland, Northern Ireland, the Isle of Man or the Channel Islands as the case may be.

Endorsements and Conditions

The following endorsements and conditions apply to this Section.

(Also refer to the Policy Endorsement and Conditions at the back of this policy booklet).

If in relation to any claim You have failed to fulfil any of the following conditions, You will lose Your right to indemnity or payment for the claim.

Directors and Officers Liability Section

Definitions

(Also refer to the Policy Definitions at the front of this policy booklet).

The following definitions apply to this Section and shall keep the same meaning wherever they appear in the Section unless an alternative definition is stated to apply.

Bodily Injury

Any injury, death, illness, sickness, psychological injury, emotional distress or nervous shock.

Claim

Any

- (1) demand whether oral or in writing, for damages or financial compensation,
- (2) notice of
 - (a) Criminal Proceedings,
 - (b) Disqualification Proceedings,
 - (c) Employment Practice Proceedings,
 - (d) Regulatory Proceedings,
 - (e) other civil or arbitration proceedings.

Computer System

Any

- (1) computer, data processing equipment, media or part thereof,
- (2) system of data storage and retrieval, communications system, network, protocol or part thereof,
- (3) storage device, microchip integrated circuit, real time clock system or similar device,
- (4) computer software (including but not restricted to application software, operating systems, runtime environments or compilers), firmware or microcode,

- (5) electronic documents utilised in the ownership, security and management of Your electronic communication system, world-wide web site, internet site, intranet site, extranet site or web address.

Criminal Proceedings

A prosecution brought before any criminal court in the United Kingdom against any Insured Person in their capacity as a director or officer of The Company.

Defence Costs

The costs and expenses incurred by an Insured Person or The Company in the investigation, defence or settlement of any Claim in so far as those costs and expenses have been incurred with Our written consent.

Defence Costs shall not include The Company's management costs or any overtime, wages, salaries or fees of any Insured Person or any of The Company's employees.

Disqualification Proceedings

Proceedings commenced by pre-action protocol letter, summons, application or claim form against any Insured Person in their capacity as a director or officer of The Company, under the Company Directors' Disqualification Act 1986.

Documents

Any

- (1) project models or displays,
- (2) deeds, wills or agreements,
- (3) maps, plans, records, photographs, negatives, calculations or drawings,
- (4) written or printed books, letters, certificates, documents or forms of any nature whatsoever,
- (5) computer software, files, documents and systems records,

which are the property of The Company or are under The Company's custody or control.

This definition shall not include bearer bonds, evidence of share ownership (whether in electronic or other form), coupons, bank or currency notes and other negotiable paper.

Legal Liabilities Directors and Officers Liability

Employment Practice Proceedings

Proceedings commenced by pre-action protocol letter, IT1 or claim form against any Insured Person in their capacity as a director or officer of The Company, arising out of any alleged or actual

- (1) discrimination including harassment,
- (2) wrongful or unfair dismissal, discharge or termination of employment,
- (3) breach of any written employment contract,
- (4) wrongful failure to promote,
- (5) wrongful demotion,
- (6) wrongful deprivation of career opportunity,
- (7) negligent evaluation,
- (8) failure to furnish accurate job references.

Excess

That first part of each and every payment in relation to a Claim or Loss which is payable by The Company or any Insured Person rather than Us. The amount of the Excess is stated in The Schedule.

The Excess shall only apply once where a series of Claim or Loss settlements arise from one source or originating cause.

We shall repay The Company or the Insured Person, as appropriate, the Excess if no damages or compensation are paid in a civil claim or no sanctions or penalties are imposed in any legal proceedings.

Insured Person

Any natural person who is or has been or who may become, during the Period of Insurance, a director or officer of The Company.

This definition shall not include any shadow director (as defined in Sections 714 (1) and (2) of The Companies Act 1985 or any subsequent amendment or re-enactment) of The Company.

Limit of Indemnity

The maximum amount, stated in The Schedule, which We will pay in respect of any one Claim (including claimant's costs and expenses and Defence Costs) and in total for all Claims first made during any one Period of Insurance.

But note that a series of Claims arising directly or indirectly from one source or originating cause shall be treated for all purposes as a single Claim.

Loss

Sums which any Insured Person is legally liable to pay in respect of any

- (1) damages, compensation or other settlements,
- (2) claimant's costs and expenses,
- (3) Defence Costs.

Outside Entity

Any company or non-profit organisation which is in some way connected with The Company, but that is not included under the definition of The Company or Insured Person.

Outside Entity Director

Any Insured Person who was, is or may become at The Company's specific request, or with The Company's approval, a director, officer, trustee, governor or similar position of an Outside Entity.

Period of Insurance

From the effective date until the expiry date stated in The Schedule.

Pollution

Any contamination by naturally occurring or man-made substances, forces or organisms or any combination of them, whether permanent or transitory and however occurring.

Proposal

Any signed proposal form, renewal declaration, statement of fact and any additional information supplied by The Company or on The Company's behalf.

Regulatory Proceedings

Investigation or enforcement proceedings commenced by official notice brought by a regulator empowered under statute against any Insured Person in their capacity as a director or officer of The Company.

Legal Liabilities Directors and Officers Liability

Subsidiary

Any organisation in which The Company

- (1) holds more than 50% of the voting rights,
- (2) holds more than 50% of the issued share capital,
- (3) has the right to appoint or remove a majority of the board of directors.

Terrorism

Any act including but not limited to

- (1) the use or threat of force or violence or,
- (2) harm or damage to life or to property (or the threat of such harm or damage) including but not limited to harm or damage by nuclear or chemical or biological or radiological means,

caused or occasioned by any person or group(s) of persons, or so claimed, in whole or in part for political, religious, ideological or similar purposes.

The Company/The Insured

The organisation and any of its Subsidiaries named in The Schedule.

Wrongful Act

Any actual or alleged

- (1) breach of duty including fiduciary or statutory duty,
- (2) negligent act, error or omission,
- (3) defamation,
- (4) breach of warranty of authority,
- (5) mis-statement or misleading statement,
- (6) wrongful trading,
- (7) other wrongful act,

committed by an Insured Person in their capacity as a director or officer of The Company.

Cover

(1) Directors and Officers Liability

We will indemnify any Insured Person for Loss arising from a Claim as the result of a Wrongful Act.

Provided that

- (a) such Claim is first made and notified to Us during the Period of Insurance and,
- (b) such Loss is not recoverable by the Insured Person from The Company in which case Cover (2) Company Reimbursement below will apply.

(2) Company Reimbursement

In the event that The Company is required or permitted to indemnify an Insured Person, We will pay on The Company's behalf for Loss arising from a Claim as the result of a Wrongful Act.

Provided that

- (a) such Claim is first made and notified to Us during the Period of Insurance and,
- (b) such Loss is not recoverable by The Company from any other source.

(3) Heirs, Spouses or Legal Representatives

In the event of an Insured Person's death, incapacity, insolvency or bankruptcy, We will indemnify their lawful heirs, marital spouse, estate or legal representatives in respect of any legal liability by reason of their lawful status for Loss arising from a Claim as the result of a Wrongful Act.

(4) Claims brought by The Company or Insured Person

In the event of action or proceedings being brought by or on behalf of

- (a) an Insured Person or,
- (b) The Company

in respect of a Claim arising from a Wrongful Act:-

Legal Liabilities Directors and Officers Liability

We will provide indemnity for Loss arising from any

- (i) shareholder derivative action,
- (ii) Claim brought by any retired director of The Company,
- (iii) Claim brought by an administrator, liquidator or receiver appointed to deal with the insolvency of The Company.

We will not provide indemnity in respect of any Claim

- (1) made against an Insured Person arising from a Wrongful Act committed prior to the Retroactive Date stated in The Schedule.
- (2) arising from proceedings brought against an Insured Person or The Company and which have been issued prior to, or which are pending at, the Prior and Pending Litigation Date stated in The Schedule.
- (3) or circumstance that might give rise to a Claim which
 - (a) have been notified to and accepted under any other insurance attaching prior to the inception of this Section or,
 - (b) an Insured Person or The Company should after reasonable enquiry have been aware of prior to the inception of this Section.
- (4) arising from a Wrongful Act by an Outside Entity Director.
- (5) arising from any Wrongful Act committed by the lawful heirs, marital spouse, estate or legal representatives of an Insured Person.
- (6) arising directly or indirectly from or in consequence of
 - (a) any dishonest, fraudulent act or omission by any Insured Person if a court judgement or other final adjudication establishes such dishonest, fraudulent act or omission,
 - (b) any Insured Person having gained any personal profit, remuneration or advantage to which they were not legally entitled.

- (7) from any action or proceedings brought by or on behalf of an Insured Person or The Company other than specifically indemnified under Cover (4) Claims Brought by The Company or Insured Person.
- (8) from an action brought by or on behalf of any past or present shareholder who had or has indirect ownership of or control over 15% or more of the voting shares or rights of The Company.
- (9) (a) from the provision of, or failure to provide, professional services or professional advice,
 - (b) a breach of any contract for the provision of professional services or professional advice.
- (10) arising directly or indirectly from any fines or penalties or any punitive, multiple, aggravated or exemplary damages where such can be identified separately within any award of any court.
- (11) directly or indirectly arising out of any
 - (a) pension or superannuation scheme,
 - (b) health and welfare plan,
 - (c) share option scheme or plan,
 - (d) other employee benefit programme, established or maintained for the benefit of The Company or The Company's employees.
- (12) arising directly or indirectly from or caused by any failure to effect or maintain any insurance policy for The Company.
- (13) arising directly or indirectly from any Bodily Injury other than Defence Costs indemnified under Cover (5) Bodily Injury Defence Costs.
- (14) arising directly or indirectly from or caused by Pollution other than Defence Costs indemnified under Cover (6) Pollution Defence Costs.
- (15) arising directly or indirectly from or caused by damage to property.

Legal Liabilities Directors and Officers Liability

(16) arising directly or indirectly from a Subsidiary established or acquired during the Period of Insurance unless We give our prior written consent to indemnity and the name of the Subsidiary is stated on The Schedule.

(5) Bodily Injury Defence Costs

We will pay Defence Costs arising from any Bodily Injury as the result of a Wrongful Act.

Our total liability in respect of such Defence Costs, during any one Period of Insurance, shall not exceed £100,000.

We will not provide any other indemnity under this Section in respect of any Claim arising directly or indirectly from Bodily Injury other than those Defence Costs indemnified above.

(6) Pollution Defence Costs

We will pay Defence Costs arising from any Pollution as the result of a Wrongful Act.

Our total liability in respect of such Defence Costs, during any one Period of Insurance, shall not exceed £100,000.

We will not provide any other indemnity under this Section in respect of any Claim arising directly or indirectly from Pollution other than those Defence Costs indemnified above.

(7) Representation Costs

We will pay on behalf of The Company or any Insured Person any reasonable costs and expenses incurred by them for representation at properly constituted hearings, tribunals or proceedings.

Provided that

- (a) such costs and expenses are incurred with Our prior written consent,
- (b) the subject of the hearing, tribunal or proceeding may become a Claim under this Section.

Our total liability under this clause shall not exceed £15,000 in all in any one Period of Insurance.

Our total liability under this Section shall not exceed the Limit of Indemnity.

We shall not be liable for the Excess or any lesser amount for which a Claim or Loss may be settled.

Exceptions

The following exceptions apply to this Section.

(Also refer to the Policy Exceptions at the back of this policy booklet).

We will not provide indemnity in respect of any Claim arising from

- (1) any Claim arising directly or indirectly from, in consequence of, contributed to or aggravated by asbestos in whatever form or quantity, whether alleged or not.
- (2) any liability of whatsoever nature directly or indirectly caused by or contributed to by or arising from
 - (a) ionising radiations or contamination by radioactivity from any nuclear fuel or from any nuclear waste from the combustion of nuclear fuel.
 - (b) the radioactive toxic explosive or other hazardous properties of any explosive nuclear assembly or nuclear component thereof.
- (3) any Claim or consequence whatsoever resulting directly or indirectly from or in connection with any of the following regardless of any other contributory cause or event
 - (a) war, invasion, act of foreign enemy hostilities or a warlike operation or operations (whether war be declared or not), civil war, rebellion, revolution, insurrection, civil commotion assuming the proportions of, or amounting to, a military uprising or usurped power
 - (b) Terrorism
 - (c) any action taken in controlling preventing suppressing or in any way relating to (a) or (b) above.

In any action, suit or other proceedings, where We allege that by reason of this definition any consequence whatsoever resulting directly or indirectly from or in connection with (a) or (b) above regardless of any other contributory cause or event is not covered by this Section (or is covered only up to a specified limit of liability), the burden of proving that any consequence whatsoever resulting directly or indirectly from or in connection with (a) or (b) above regardless of any other contributory cause or event is covered (or is covered beyond that limit of liability) shall be upon The Company.

- (4) any Claim of whatsoever nature arising directly or indirectly from or caused by the failure or inability or any alleged failure or inability of any Computer System, whether the property of The Company or not, at any time to achieve any or all of the purposes and consequential effects intended by the use of any number, symbol or word to denote a date, including without limitation, the failure or inability to recognise capture save retain or restore and/or correctly to manipulate, interpret, transmit, return, calculate or process any date, data, information, command, logic or instruction as a result of
- (a) recognising using or adopting any date, day of the week or period of time, other than the true or correct date, day of the week or period of time.
 - (b) the operation of any command or logic which has been programmed or incorporated into any Computer System.
- (5) any Claim instituted or pursued
- (a) in the United States of America, its territories or possessions or Canada (including without limitation the enforcement of a judgement or finding of a court or tribunal of another jurisdiction or otherwise).
 - (b) in which it is contended that the laws of the United States of America, its territories or possessions or Canada should or do apply.
 - (c) which involves the enforcement or attempted enforcement of a judgement or finding of a court or tribunal of the United States of America, its territories or possessions or Canada.

Conditions

The following conditions apply to this Section.

(Also refer to the Policy Conditions at the back of this policy booklet).

Claims Conditions

If in relation to any Claim, The Company fails to fulfil or observe the requirements imposed upon it by (1), (2) or (3) The Company or any Insured Person will lose their right to indemnity or payment for that Claim.

(1) Claims Notification

If during the Period of Insurance, regardless of any Excess, The Company or any Insured Person

- (a) receive any Claim, The Company shall give written notice to Us as soon as practicable,
- (b) become aware of any circumstance that might give rise to a Claim, The Company shall give written notice to Us of such circumstance as soon as practicable. Any Claim subsequently arising from any circumstance notified to Us shall be deemed to have been made during the Period of Insurance in which the notice of such circumstance was first received by Us,
- (c) discover a reasonable cause for suspicion of any dishonesty or fraud on the part of any Insured Persons, whether giving rise to a Claim or not, The Company shall give written notice to Us of such discovery as soon as practicable.

Provided always that any such written notice under any part of this Condition (1) is received by Us during the Period of Insurance.

Legal Liabilities Directors and Officers Liability

Any written notice should be sent to

(2) Admission of Liability

In the event of a Claim or the discovery of a circumstance that might give rise to a Claim, The Company or any Insured Person must not admit liability for or settle any Claim, or incur any related costs or expenses, without Our written consent.

(3) Claims Control and Subrogation

In the event of a Claim or the discovery of a circumstance that might give rise to a Claim, We will be entitled, at Our own expense at any time, to take over and conduct in the name of an Insured Person the defence or settlement of any such Claim or circumstance.

We shall not settle any Claim without the consent of the Insured Persons. If however the Insured Persons shall refuse to consent to any settlement recommended by Us, then Our liability for such Claim (including Defence Costs) shall not exceed the amount for which the Claim could have been settled inclusive of Defence Costs, incurred with their consent up to the date of such refusal and then only up to the Limit of Indemnity stated in The Schedule.

If We do take over and conduct the defence or settlement of any such Claim, The Company or any Insured Person shall give Us all such information and assistance as We may reasonably require and that is in The Company's or any Insured Person's power to provide.

Without prejudice to the generality of the above, Your duty to assist Us includes

- (a) providing all such information, assistance, signed statements or depositions as may be required to facilitate compliance with any civil procedure rules, practice directions and pre-action protocols as may be issued,
- (b) allowing Us to present the best possible defence of a Claim within the time constraints available,
- (c) ensuring ready access to all and any information that We may require in the defence of a Claim or investigation of a Loss,
- (d) ensuring the payment, on demand, of the Excess in conjunction with the terms of any settlement agreed by Us.

We retain all rights of recovery available to The Company or any Insured Person in respect of any payment which may be made under this Section.

General Conditions

Allocation

We will do all that is reasonably required to determine a fair and equitable allocation between any Loss which is indemnified and any other losses or costs which are not indemnified under this Section taking into account the relative legal liability of each party involved.

If We cannot agree on a fair and equitable allocation with The Company or the Insured Person, then the issue will be referred to a senior barrister (to be mutually agreed upon by the Insured Person, The Company and Us) for arbitration whose decision shall be binding on all parties.

Authorisation

The Company shall act upon behalf of any Insured Person or any other persons who may be entitled to indemnity under this Section in respect of

- (1) the notification of any Claims in accordance with Claims Conditions (1), (2) and (3),

Legal Liabilities Directors and Officers Liability

- (2) the payment of premiums or the receiving of any return premiums that may become due under this Section,
- (3) the negotiation, agreement to an acceptance of renewal terms, and endorsements applying to this.

Change of Control

If

- (a) an offer is made, and declared or made unconditional, for the whole, or a controlling interest in the issued share capital of The Company or
- (b) there is a change in ownership of the controlling interest of the share capital of The Company

We will only provide indemnity in respect of any Wrongful Act committed prior to the date such offer was declared or made unconditional or the change of ownership became effective.

Contracts (Rights of Third Parties)

A person or company who is not a party to this Section has no right under the Contracts (Rights of Third Parties) Act 1999 to enforce any terms of this Section but this does not affect any right or remedy of a third party which exists or is available apart from that Act.

Jurisdiction

This Section is subject to the relevant law of the United Kingdom (including the Channel Islands and the Isle of Man) applicable to The Company's main address as stated in The Schedule.

In the event of any dispute, the law of England and Wales and the courts of England and Wales will have exclusive jurisdiction for hearing and determining any litigation arising out of or in connection with this Section.

Liquidation

In the event of The Company's liquidation, the Section shall remain in force until the expiry date of the Period of Insurance unless cancellation is requested by all of The Company's directors. We will continue to provide indemnity but only in respect of any Claim as the result of a Wrongful Act prior to the date of liquidation.

The date of liquidation will be deemed to be the date on which

- (1) a resolution for voluntary liquidation is passed by The Company or,
- (2) a petition for compulsory liquidation is presented to the relevant authority.

Other Insurances

If any Insured Person is, or would be but for the existence of this Section, entitled to indemnity under any other Section in respect of any Claim or Loss, We shall not be liable for any Loss or Defence Costs except in respect of any amount in excess of that which would have been payable under such insurance had this Section not been affected.

Prospect of Success

We shall not be required to contest or continue to contest any Claim or legal proceedings if at any stage a senior barrister (to be mutually agreed upon by the Insured Person and Us) shall advise that such action does not have a reasonable prospect of success.

Public or Private Offering

If The Company makes a Public or Private Offering during the Period of Insurance, no indemnity will be provided under this Section for any Claims arising directly or indirectly from such Offering until The Company has provided written notice to Us, including any information reasonably required, and We give Our consent and state such on The Schedule.

We reserve Our rights to amend the terms and conditions of this Section in respect of such Offering.

Severability

For the purposes of determining indemnity under this Section, no knowledge possessed or any statement made in any Proposal by any single Insured Person shall be imputed to any other Insured Person.

Policy Conditions

Each Section of the policy contains conditions. They must be read in conjunction with the following Policy Conditions which apply to all Sections unless otherwise stated.

(1) Alteration of Risk

We will at Our option avoid the policy from the inception of this insurance where

- (a) there has been any alteration to the Property Insured and/or The Premises and/or The Business after the effective date of this insurance which increases the risk of loss, liability, destruction, damage, accident or injury

or

- (b) Your interest ceases except by will or operation of law

unless We have accepted the alteration.

(2) Arbitration

If We accept liability but You disagree with the amount We offer to pay, the claim will be referred to an arbitrator who will be appointed in accordance with statutory provisions.

(3) Cancellation

We may cancel the policy

- (a) by sending You 30 days written notice to Your last known address.

We will refund a proportionate part of the premium paid for the unexpired period.

- (b) immediately if the premium has not been paid or if there has been a default under an instalment or linked credit agreement.

We will not refund any instalment paid.

(4) Claims Procedure

If in relation to any claim You have failed to fulfil any of the following conditions, You will lose Your right to indemnity or payment for that claim.

You must

- (a) tell Us immediately of any event or occurrence which may result in a claim.
- (b) notify the police immediately of loss, destruction or damage caused by malicious persons or thieves.
- (c) at Your expense, provide Us with a written claim containing as much information as possible of the loss, liability, destruction, damage, accident or injury including the amount of the claim within
 - (i) 30 days
 - or
 - (ii) seven days in the case of loss, destruction or damage caused by riot, civil commotion, strikers, locked out workers, persons taking part in labour disturbances or malicious persons

of you becoming aware of the event or occurrence, or such further time that We may allow.

- (d) provide Us with all information and help We require in respect of the claim.
- (e) pass to Us unanswered, immediately, all communications from third parties in relation to any event which may result in a claim under this policy.
- (f) not admit or repudiate liability, nor offer to settle, compromise, make payment which may result in a claim or pay any claim under this policy without Our written agreement.
- (g) allow Us to take over and conduct in Your name the defence or settlement of any claim. You will also allow Us to prosecute at Our own expense and for Our own benefit, any claim for indemnity or compensation against any other person and You must give Us all information and assistance required.

Policy Conditions

(5) Contribution

Applicable to Employers' Liability Section and Property Owner's Liability Section

- (a) If the insurance provided by these Sections is also covered by another policy (or would be but for the existence of these Sections), We will only indemnify You in respect of any excess beyond the amount which would be payable under such other insurance had these Sections not been effected.

Applicable to all other Sections insured by this policy

- (b) Where any loss, destruction, damage or liability covered by the policy is also covered by another policy, (or would be but for the existence of this policy), We will only pay a rateable share of the loss.
- (c) If the other insurance is subject to a condition of Average and this policy is not, this policy will become subject to the same condition of Average.
- (d) If the Property Insured covered by the other insurance is subject to a provision excluding proportional payment in whole or in part, the payment We make will be limited to the proportion of loss, destruction or damage as the Sum Insured bears to the value of the property.

(6) Discharge of Liability

We may at any time pay

- (a) the Limit of Indemnity

or

- (b) the Sum Insured

or

- (c) a smaller amount for which a claim can be settled

after deduction of any sum already paid.

We will not be liable for any further payment except for costs and expenses incurred prior to the payment of the claim or with our consent.

(7) Fraud

We will at Our option avoid the policy from the inception of this insurance or from the date of the claim or alleged claim, or avoid the claim

- (a) if a claim made by You or anyone acting on Your behalf to obtain a policy benefit is fraudulent or intentionally exaggerated, whether ultimately material or not

or

- (b) a false declaration or statement is made or fraudulent device put forward in support of a claim.

(8) Identification

The policy and The Schedule will be read as one contract.

(9) Non Disclosure, Misrepresentation or Misdescription

The policy is voidable if there has been any misrepresentation, misdescription or failure to disclose any material fact by You or anyone acting for You.

(10) Reasonable Precautions

If in relation to any claim You have failed to fulfil any of the following conditions, You will lose Your right to indemnity or payment for that claim.

You must

- (a) maintain The Premises, machinery, plant and equipment in a satisfactory state of repair.

- (b) take all reasonable precautions to prevent

- (i) loss or destruction of or damage to the Property Insured.
(ii) accident or injury to any person or loss, destruction or damage to their property.

- (c) comply with all legal requirements and safety regulations and conduct The Business in a lawful manner.

Policy Conditions

- (d) keep books with a complete record of purchases and sales.

(11) Reinstatement

When We decide, or are required to reinstate or replace any property You will, at Your expense, provide any

- (a) plans
- (b) documents
- (c) books
- (d) information

which We require.

We will not be obliged to reinstate property exactly but only in a satisfactory manner as circumstances allow.

The maximum amount We will pay in respect of any one item is the Limit of Indemnity or the Sum Insured for that item.

(12) Subrogation

Anyone making a claim under this policy must, at Our request and expense, do everything We reasonably require to

- (a) enforce a right or remedy
- or
- (b) obtain relief or indemnity

from other parties to which We will become entitled or subrogated because of payment for or making good loss, destruction, damage, accident or injury.

We may require You to carry out such actions before or after We make any admission of or payment of a claim.

(13) Index Linking

- (a) Renewal.

Where it states in The Schedule that index linking applies, the amounts insured will be adjusted for movements in the following indices. We may select alternative measures if any of these indices are unavailable

- (i) any building and tenants improvements item

The General Building Cost index issued by the Building Cost Information Service of the Royal Institution of Chartered Surveyors

- (ii) other items

The Producer Price Index for Home Sales of Manufactured Products issued by the relevant government department.

- (b) Claims.

These adjustments will continue during the

- (i) Period of Insurance
- (ii) period of repair, replacement or reinstatement provided that such work is carried out and completed without undue delay.

(14) Long Term Undertaking

Where a Section is stated in The Schedule to be subject to Long Term Undertaking a discount of 5% under that Section is allowed in consideration of You having provided an undertaking with effect from the date stated in The Schedule to offer annually for a period of three years the insurance under the Section on the terms and conditions in force at the expiry of each Period of Insurance and to pay the premiums annually in advance, it being understood that:

- (a) We shall be under no obligation to accept an offer made in accordance with such an undertaking
- (b) the Sums Insured may be reduced at any time to correspond with any reduction in value or reduction in The Business.

The discount does not apply to any inspection fees charged under the Engineering Section of this policy.

The above mentioned undertaking applies to any policy which may be issued by Us in substitution for this policy and the same discount shall be allowed.

Policy Conditions

(15) Subjectivity

The policy, the application form, statement of fact and/or declaration made by You, and The Schedule, should be read together and form the contract of insurance between You (The Policyholder,) and Us (Norwich Union.)

- (a) We will clearly state in The Schedule if the Cover provided by the policy is subject to You:
- (i) providing Us with any additional information requested by the required date(s),
 - (ii) completing any actions agreed between You and Us by the required date(s),
 - (iii) allowing Us to complete any actions agreed between You and Us.
- (b) If required by Us, You must allow Us access to The Premises, Your Contract Sites, and/or The Business, to carry out survey(s), within 60 days of the inception or renewal date, unless We agree otherwise in writing.

Upon completion of these requirements (or if they are not completed by the required dates), We may, at Our option:

- (i) modify Your premium,
- (ii) issue a mid-term amendment to Your policy or Section terms and conditions,
- (iii) require You to make alterations to The Premises insured by the required date(s),
- (iv) exercise Our right to cancel Your policy,
- (v) leave the policy or Section terms and conditions, and Your premium, unaltered.

We will contact You with Our decision and where applicable, specify the date(s) by which any action(s) agreed need to be completed by You and/or any decision by Us will take effect.

Our requirements and decisions will take effect from the date(s) specified unless and until We agree otherwise in writing. If You disagree with Our requirements and/or decisions, We will consider Your comments and where We consider appropriate, will continue to negotiate with You to resolve the matter to Your and Our satisfaction. In the event that the matter cannot be resolved:

- (i) You have the right to cancel this policy from a date agreed by You and Us and, providing no claims have been made, We will refund a proportionate part of the premium paid for the unexpired period of cover.
- (ii) We may, at Our option, exercise Our right under Policy Condition **(3) Cancellation**.

Except where stated all other policy and Section terms and conditions will continue to apply.

The above conditions do not affect Our right to void the policy if We discover information material to Our acceptance of the risk. Please refer to the **IMPORTANT** note within The Contract of Insurance page of Your policy booklet.

Policy Exceptions

Each Section of the policy contains exceptions. They must be read in conjunction with the following Policy Exceptions which apply to all Sections unless otherwise stated.

We will not provide indemnity in respect of

- (1) any consequence whatsoever resulting directly or indirectly from or in connection with any of the following, regardless of any other contributory cause or event
 - (a) war, invasion, act of a foreign enemy, hostilities or a warlike operation or operations (whether war be declared or not), civil war, rebellion, revolution, insurrection, civil commotion assuming the proportions of or amounting to an uprising, military or usurped power
 - (b) nationalisation, confiscation, requisition, seizure or destruction by any government or any public authority
 - (c) any action taken in controlling, preventing, suppressing or in any way relating to (a) and/or (b) above.

However,

- (1) exceptions (1) (a) (b) and (c) do not apply to the following Sections, when insured by this policy.
 - (a) Employee Dishonesty
 - (b) Terrorism
 - (c) Employers' Liability.
 - (d) Professional Indemnity
 - (e) Directors and Officers
- (2) exception (1) (b) does not apply to the Property Owner's Liability Section, when insured by this policy.
- (2) death or disablement, loss or destruction of or damage to any property, any loss or expense whatsoever, any consequential loss or any legal liability
 - (a) directly or indirectly caused by or contributed to by or arising from
 - (i) ionising radiations or contamination by radioactivity from any nuclear fuel or from any nuclear waste or from the combustion of nuclear fuel

- (ii) the radioactive, toxic, explosive or other hazardous or contaminating properties of any nuclear installation, reactor or other nuclear assembly or nuclear component thereof.

- (b) directly or indirectly caused by or contributed to by or arising from the use of or threatened use of any weapon

- (i) dispersing radioactive material and/or ionising radiation or

- (ii) using atomic or nuclear fission and/or fusion or other like reaction.

However,

- (1) exception (2) (b) above does not apply to the following Sections, when insured by this policy.

- (a) Employers' Liability

- (b) Property Owner's Liability.

- (2) in relation to the Employers' Liability Section, exception (2) (a) above only applies when You under a contract or agreement have undertaken to

- (a) indemnify another party

- (b) assume the liability of another party.

- (3) exceptions (2) (a) and (b) do not apply to the following Sections, when insured by this policy.

- (a) Employee Dishonesty

- (b) Terrorism

- (c) Professional Indemnity

- (d) Directors and Officers

- (3) (a) Money

- (b) securities or bonds

- (c) jewellery or precious stones

- (d) precious metals or bullion

- (e) furs or curios

- (f) rare books or works of art

Policy Exceptions

- (g) goods held in trust or on commission
- (h) documents or manuscripts
- (i) business books or computer systems records
- (j) explosives
- (k) property in transit

unless specifically mentioned.

However, exceptions (3) (a) to (k) do not apply to the following Sections, when insured by this policy

- (1) Terrorism
- (2) Employers' Liability
- (3) Property Owner's Liability
- (4) Property Owner's Legal Protection
- (4) any claim which arises directly or indirectly from or consists of the failure or inability of any
 - (a) electronic circuit, microchip, integrated circuit, microprocessor, embedded system, hardware, software, firmware, program, computer, data processing equipment, telecommunication equipment or systems, or any similar device
 - (b) media or systems used in connection with anything referred to in (a) above

whether Your property or not, at any time to achieve any or all of the purposes and consequential effects intended by the use of any number, symbol or word to denote a date and this includes without any limitation the failure or inability to recognise, capture, save, retain or restore and/or correctly to manipulate, interpret, transmit, return, calculate or process any date, data, information, command, logic or instruction as a result of

- (i) recognising, using or adopting any date, day of the week or period of time, otherwise than as, or other than, the true or correct date, day of the week or period of time
- (ii) the operation of any command or logic which has been programmed or incorporated into anything referred to in (a) and (b) above.

However,

- (1) We will not exclude any claim for subsequent loss or destruction of or damage to any property or consequential loss which itself results from a Defined Contingency arising under any of the following Sections, but only to the extent that such claim would otherwise be insured under that Section

(a) Property Damage

(b) Money and Assault

(c) Business Interruption

- (2) exceptions 4 (a) and (b) do not apply to the following Sections, when insured by this policy

(a) Employee Dishonesty

(b) Terrorism

(c) Employers' Liability

(d) Professional Indemnity

(e) Directors and Officers

Definition

The following definition only applies to this exception

'Defined Contingency'

fire, lightning, explosion, aircraft and other aerial devices or articles dropped from them, riot, civil commotion, strikers, locked out workers, persons taking part in labour disturbances, malicious persons other than thieves, earthquake, storm, flood, escape of water from any tank apparatus or pipe, impact by any road vehicle or animal, or theft.

- (5) any claim (other than in respect of Personal Injury as defined under the Property Owner's Liability Section) arising directly or indirectly from, or in connection with, or consisting of

(a) Loss of Data

Policy Exceptions

However, We will not exclude any claim arising directly or indirectly from, or in connection with, or consisting of Loss of Data, which claim is not otherwise excluded and which results from a Malicious Contingency involving physical force and violence or a Specified Contingency where either is insured under any of the following Sections of the policy and only to the same extent that such claim is insured under that Section

- (i) Property Damage - Specified Contingencies
- (ii) Property Damage - All Risks
- (iii) Money and Assault
- (iv) Business Interruption.

Exception (5) (a) does not apply to the Property Owner's Liability Section, when insured by this policy.

- (b) any loss, destruction or damage, Failure or Loss of Data resulting directly or indirectly from, or in connection with: Virus or Similar Mechanism, Denial of Service Attack, unauthorised access to or use of Computer and Electronic Equipment.

However, We will not exclude any claim in respect of any subsequent physical loss or destruction of or damage to property other than Computer and Electronic Equipment and Data Storage Materials, which is not otherwise excluded and which results from a Malicious Contingency involving physical force and violence or a Specified Contingency where either is insured under any of the following Sections of the policy and only to the same extent that such subsequent physical loss or destruction of or damage to property is insured under that Section.

- (i) Property Damage - Specified Contingencies
- (ii) Property Damage - All Risks
- (iii) Money and Assault
- (iv) Business Interruption.

Exceptions (5) (a) and (b) do not apply to the following Sections, when insured by this policy.

- (1) Employee Dishonesty
- (2) Engineering
- (3) Terrorism
- (4) Employers' Liability
- (5) Property Owner's Legal Protection
- (6) Professional Indemnity
- (7) Directors and Officers
